- 3. The selection of candidate for each post shall be as per criteria notified in this advertisement.
- 4. All engagements shall be purely on contractual basis and non-transferable.
- 5. Initial term of contract shall be for the remaining period of financial year or till continuation of centrally sponsored scheme whichever is earlier.
