**TENDER NOTICE**

**Subject: Hiring of Commercial vehicles having valid permit for RBSK Mobile Health Teams, at Block Level under National Health Mission in District Kulgam**

Sealed tenders are invited for empanelment of Tour /Vehicle Operators/Owners in District Kulgam for the Mobile Health Teams at the Blocks (DH Pora, Qaimoh, Qazigund, Yaripora, Kulgam) under Rashtriya Bal Swasthya Karyakaram (RBSK), National Health Mission in District Kulgam

The interested parties are requested to submit the sealed tenders affixed with Rs.5.00 revenue stamp (clearly marked on the envelop – BID FOR HIRING OF VEHICLE) for the Mobile Teams under RBSK in District Kulgam

Sealed tenders must reach the office of the Vice Chairman Convenor District Rural Health Society (Chief Medical Officer Kulgam ) within ten (10) days from the date of publication of Tender notice. However, opening of sealed tenders shall be communicated separately & will be opened in presence of Committee & Bidders. The acceptance and finalization of tenders shall be subject to the following terms & conditions:-

**Terms and Conditions:-**

1. The Vehicle must not be below the model of 2012 and should be in excellent running conditions (Scorpio/Innova/Tavera/Bolero/Xylo etc.)
2. The interested parties shall quote the rate for hiring on Monthly basis exclusive of Fuel (as per the format given below).
3. The Fuel shall be provided by the Department at Block Level, as per the Circular issued by Directorate of State Motor Garages J&K issued vide Office endorsement No: RCD-12/4443-47/DSMG, Dated: 19/01/2017.
4. The Bid shall be enclosed with all the relevant documents viz. Proof of Ownership, Registration Certificate, Insurance, Permit, Pollution Certificate, Fitness Certificate, Tax Payment Book, Driving License.
5. An affidavit of RS 100 stamp paper duly attested by ist class magistrate with the effect that the documents enclosed herewith are genuine and have not been tampered or fabricated.
6. The rates will be all inclusive, including maintenance of the vehicle.
7. Vehicles will operate from Block Headquarter to the Schools and Aanganwadi Centers in the concerned Blocks as per the Tour Plan and back to respective Block Headquarter.
8. Vehicles will remain at the exclusive disposal of the Block Head quarter and can not be used by the bidder for any other purpose during the period of the Rate Contract.
9. The hiring shall be made for 10 vehicles only, for five Medical Blocks of District Kulgam two (02) per block.
10. The hiring is up to 31-03-2021 and may be renewed on the sole discretion of District Health Society Kulgam.

12. The successful tenderer shall have to execute an agreement with concerned Block Medical Officer.
13. The Successful tenderer has to install vehicle tracking and Management System as and when directed by State Health Society the charges for the same shall be borne by the successful bidder.
14. The District Rural Health Society is empowered to disengage any vehicle at any time if the condition of the vehicle is not good and in case of misconduct by Driver.
15. The tender should accompany CDR of Rs.2000/- (per vehicle) pledged to Chief Medical Officer Kulgam which shall be released to successful tenderer after completion of contract i.e.; as on 31-3-2021 after finalization of rates. In case, the Tenderer has submitted tender for more than one vehicle, separate CDR (each amounting Rs 2000/-) should be attached with respect to the number of vehicles.
16. The payment for use of vehicle shall be released at concerned Block Level on production of bill along with daily logbook duly certified by the concerned Touring Officer as well as concerned Block Medical Officer.
17. TDS shall be deducted as per the norms.
18. The Tenderer should have valid PAN number for deduction of TDS.
19. The Vehicle shall start from Block Headquarters and has to report back to the same place & no individual employee shall be picked/dropped from his/her residence.
20. The vehicle shall be halt at Block Headquarter on own risk & responsibility.
21. Driver should be authentic license holder, decent, well behaved, should not have any criminal cases against him & should not have any past history of accidents.
22. Insurance of the vehicle, payment of toll tax, pollution certificate etc will be responsibility of owner of the vehicle, for which any violation, the CMO Kulgam (Vice Chairman DHS) shall not be responsible.
23. In case of Vehicle breakdown, a substitute vehicle has to be provided by the contractor immediately and in case the vehicle does not report within the reasonable time or does not report on time, the concerned Block Medical Officer would have to hire the vehicle from the market & the charges incurred will be borne by the contractor.
24. The successful bidder shall ensure that the vehicle hired under RBSK shall be branded immediately, as per the design & text prescribed by the State Health Society J&K and charges for same shall be borne by the successful bidder.
25. The contract will be offered only after proper verification of all the relevant documents.
26. Chief Medical Officer (Vice Chairman DHS) Kulgam reserves the right to accept or reject any tender without giving any reason thereof.
