Subject:- Apportionment of Manpower between UT of Jammu and Kashmir and UT of Ladakh representation regarding relieving of officers/ officials thereof.

Sir/ Madam,

The Administrative Department vide letter No: HD-Cord/168/2021-02 dated: 30-11-2021 while referring to Govt. Order No: 1212-JK (GAD) of 2021 dated: 15-11-2021 issued by the General Administration Department with the instructions to relieve all such officers/ officials who names are figuring in the annexure of said Government order and are presently working under the administrative control of this Directorate, after fulfilling all codal formalities required under rules are in vogue, so that officers/ officials may be able to join in the UT of Ladakh for further duties.

General Administration Department vide order dated: 15-11-2021 has framed Department-wise summary of employees opting to serve in the Union Territory of Ladakh, among others (1753) employees have been shown from Health & Medical Education Department mentioned in annexure with other particulars as shown against each and has conveyed following observations:

1. The employees figuring in Annexure to this order are hereby apportioned to the Union Territory of Ladakh.
2. The remaining employees of the erstwhile State of J&K serving on substantive basis, excluding those figuring in the Annexure to this order are hereby apportioned to the Union Territory of J&K.
3. Any variation in the details/ credentials of employees apportioned to Union Territory of Ladakh shall be rectified after considering original/ verified service records by the concerned Controlling Authorities, with approval of the competent authority.


It is further ordered that:

1. The employees already serving in any of the successor Union Territories to which they have been apportioned, shall continue to serve in the respective Union Territory viz, Union Territory of J&K and Union Territory of Ladakh.
2. The employees apportioned to Union Territory of Ladakh and continuing their service in the Union Territory of J&K shall be relieved by the concerned Administrative Departments immediately.

3. The employees apportioned to the Union Territory of J&K and continuing their service in the Union Territory of Ladakh shall continue to do so, till further orders. Their repatriation shall be considered separately, on case to case basis.

Accordingly, you are requested to down load Govt. Order No: 1212-JK (GAD) of 2021 dated: 15-11-2021 and follow the instructions of Administrative Department as well as General Administration Department in letter & spirit and relieve immediately the officers/ officials figuring in the annexure whose appointment/ service is governed by the condition No: (2) of the aforementioned Govt. Order mentioned/ highlighted overleaf and working under your administrative control with the instructions to report to the General Administration Department, Union Territory of Ladakh for further posting/ duties under intimation to this Directorate. //
