Subject: Cancellation of appointment of Smt. Neeru Bhat D/o Girdari Lal R/o Pergochi Shopian Jr. Physiotherapist Divisional Cadre Kashmir pursuant to advertisement notification No: 03 of 2012 dated: 28-12-2012, item No: 158.

Whereas, the Administrative Department vide letter No: HD/NG/320/2015 dated: 06-01-2016 forwarded the selection list of Jr. Physiotherapists Divisional Cadre Kashmir whose candidature was recommended by the respective recruiting agency & endorsed vide Secretary, J&K, SSB Srinagar's letter No: SSB/Secy/Sel/2015/11095-11102 dated: 27-10-2015 pursuant to advertisement notification No: 03 of 2012 dated: 28-12-2012, item No: 158 with the advice to issue formal appointment orders in favour of the selected candidates after fulfillment of terms & conditions.

Whereas, amongst others, the name of one Smt. Neeru Bhat D/o Girdari Lal R/o Pergochi Shopian was figuring at S.No:01 under RBA category in the waiting list in the aforesaid selection list but her candidature was not recommended for the purpose of appointment as the same was kept withheld for want of certain clarification and accordingly her case could not be processed in view of instructions conveyed by the Administrative Department vide letter dated: 06-01-2016, till clearance from the respective recruiting agency.

Whereas, vide communication No: HD/NG/320/2015 dated: 19-07-2016, a revised selection list formulated by the J&K, SSB in terms of Order No: 1218 SSB of 2016 dated: 18-06-2016 was forwarded to this Directorate by the Administrative Department for further needful. In the said revised selection list the recommendation of the above named candidate was also released for her appointment to the post of Jr. Physiotherapist Divisional Cadre Kashmir.

Whereas, in the first instance formal appointment orders in respect of 24 selected candidates to the post of Jr. Physiotherapists, Divisional Cadre Kashmir were issued by this Directorate vide Order No: 511/NG of 2016 dated: 29-07-2016.

Whereas, vide this office Order No: 522/NG of 2016 dated: 11-08-2016, this Directorate issued formal appointment order in favour of above named candidate against the post of Jr. Physiotherapist at SDH Zainpora District Shopian under RBA category on the same terms & conditions as stipulated in the communication dated: 06-01-2016 and in the said order the appointee was directed to report respective DDO/CMO/BMO within a period of (21) days from the date of issuance of her appointment order.

Whereas, it was made mention in the said appointment order that in the event of failure on the part of appointee to join her place of posting, the appointment so made shall be deemed to have been cancelled ab-initio without any notice.

Whereas, the above named incumbent failed to join the Department at her place of posting viz, SDH Zainpora District Shopian in compliance to aforesaid appointment order and ultimately on 04-04-2017, she approached in this Directorate through a medium of an application seeking revalidation of formal appointment order and permission for joining the post against which she was appointed citing reasons that due to unrest in the valley at that point of time she was not aware about her appointment and hence could not join the Department.

Whereas, the request of the above named candidate was submitted with full factual details to the Administrative Department vide this office letter No: Est-4/NG-39/858 dated: 09-10-2017 for consideration. In response, the Administrative Department vide letter No: HD/NG/3202015-Par file dated: 10-04-2018 advised to intimate as to whether the appointment order was served to the candidate on her address/ published in print media.

Whereas, vide letter No: Est-4/NG-39/545 dated: 28-08-2018, the Administrative Department was apprised about the facts & other circumstances which contemplated this Directorate for non publication of the appointment order in the print media and not serving of the same to the incumbent.

Whereas, the Administrative Department vide letter No: HD/NG/320/2015-Part file dated: 28-09-2020 intimated that the matter was taken up with the General Administration Department for opinion/ advice. The opinion rendered by the General Administration Department in the instant matter has been conveyed to this Directorate with the advice to proceed further in the matter in accordance with the remarks/ directions of General Administration Department.

Now therefore, in view of position given herein above and in pursuance of the opinion rendered by the General Administration Department received vide Administrative Department's letter No dated: 28-09-2020, the formal appointment

As regards implementation of 2nd portion of the opinion of the General Administration Department, necessary orders to this effect shall follow separately. //


