Whereas, the Chief Medical Officer Anantnag vide his letter No:-Est/2nd/Compt/Apptt/SRO-43/4408-09 Dated:- 31.08.2021 forwarded the compassionate appointment case of Mr. Aamir Nazir S/O:- Nazir Ahmad Shah & Late Rafiqa Banoo Ex-Jr. Grade Nurse R/O:-Kotheir Nowgan, Shangus District Anantnag under and interms of J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 Dated:-22.02.1994 on the plea that his mother was working in the department as Jr. Grade Nurse at Block Shangus District Anantnag who died in harness on 01.06.2021 as per the Death Certificate Issued by Station House Officer Police Station Achabal along with the allied requisite documents.

Whereas, in the dependant certificate issued by the Additional Deputy Commissioner (Rev) Anantnag vide his No.68/LH/Dep/SRO-43 Dated:-05.08.2021, the incumbent namely Aamir Nazir Shah has been reflected as dependent upon his deceased mother and as per Legal Hier Certificate issued by Assistant Commissioner (Rev) Anantnag vide NO.ACRANA/LEGAL/ON/20213924 Dated:-16.07.2021, the deceased Jr. Grade Nurse has left behind the following legal hiers after her demise.

Whereas, the case of of the incumbent was processed in this office and it was decided at the outset to forward his verification rolls to the office of Additional Director General of Police CID, J&K Govt. Srinagar for verifying his character antecedents purely in terms of provisions contained in Govt. Order No.528-JK (GAD) of 2021 Dated:-21.06.2021 issued by General Administration Department.

Whereas, taking cognizance, this office forwarded the verification rolls along with other testimonials to the concered issuing authorities for verification of his character antecedents and verification of his credentials viz D.O.B and Domicile Certificate under different communications.

Whereas, in response the Dy.SP (Hqrs) For Spl. Director General CID, J&K, Jammu vide letter No.CID/MR/SRO-43/2021/613 Dated:-25.02.2021 forwarded the necessary report of the incumbent which is reproduced as under:-

"Ground verifications conducted reveal that nothing adverse has been reported against the individual Aamir Nazir Shah as well as his deceased mother. The mother of the individual namely Rafiga Banoo was working in Health Department, who died due to COVID-19 on 01.06.2021 at GMC Anantnag."

Whereas, besides, Assistant Commissioner (Rev) Anantnag and Assistant Secretary Verification-KD J&K Board of School Education, Bemina Srinagar Kashmir vide letter NO.DCA/Misc/1497 Dated:-28.09.2021 and No.F(JS-Ver)BKD/2021/F-4647 Dated:-21.09.2021 respectively forwarded the verification reports of Domicile and Date of Birth Certificates which transpires that both the certificates are genuinue and have been issued by their respective departments and reflects the D.O.B of applicant as 20.03.1991.

Whereas, the aforementioned legal hier of the deceased Jr. Grade Nurse appearing at S.No.01 has tendered affidavit duly authenticated by Judicial Magistrate Ist Class Shangus Anantnag to the effect that he has no objection if Sr. No.02 namely Aamir Nazir Shah is appointed in terms of SRO-43 of 1994 in place of deceased mother.

whereas, the Sr. No.02 namely Aamir Nazir Shah (applicant) has also submitted an affidavit duly attested by the Judicial Magistrate Ist Class Shangus Anantnag to the effect that in case he is appointed under SRO-43 of Shangus Anantnag to the family left behind by his deceased mother, in the 1994, he will look after the family left behind by his deceased mother, in the event of failure the department shall be at liberty to initiate any action as warranted under rules, which include termination of his services without prior notice.

Now, therefore, in view of the above narrated details and in tems of the J&K Compassionate Appointment Rules, 1994 notified vide SRO-43 Dated:-22.02.1994 as amended from time to time coupled with the recommendations/submissions made by the Chief Medical Officer Anantmag, Sanction is hereby accorded to the temporary appointment of Mr. Aamir Nazir Shah S/O:- Nazir Ah. Shah & Late Rafiqa Banoo Ex-Jr. Grade Nurse R/O:-Kothier, Nowgam, Shangus District Anantmag as Class Ivth in Pay Level SL-1 (14800-47100) plus allowances as admissible under against available vacancy at Block Larnoo District Anantmag subject to the condition that he will look after and serve the legal hiers of his deceased mother and in case he violated terms and conditions of the affidavit submitted by him in this Directorate, his services shall be terminated abintio without any notice.

The appointee shall report to the office of Chief Medical Officer Anantnag within a period of 21 days from the date of issuance of this order and in the event of failure, the appointment shall deem to have been cancelled abinitio without any notice and shall be allowed to join only on production of the following documents/certificates to be verified subsequently:-

- Academic Qualification Certificate.
- 2. Age and Health Certificate.
- 3. Permanent Resident Certificate.
- 4. Dependant Certificate issued by the competent authority.
- 5. All other relevant documents as are required under SRO-43 of 1994.
- No Loan Certificate under Self Employment Scheme from DIC Concerned and Employment Department.
- It shall be the binding/obligatory on the appointee to serve the breaved family with the income to be derived from the said employment for which an undertaking shall also be obtained from the appointee, duly attested by the First Class Magistrate.
- 2. Any confirmed deviation from the agreement shall result in the forfeiture of the job for which the appointing authority (Director Health Services Kashmir) shall on receipt of such complaint have the authority to initiate actin and the appointee in such case shall be left with no right to agitate the matter before any forum whatsoever, after decision taken by the appointing authority.
- 3. The appointee shall be on probation for a period of two years and shall be governed by the provisions of SRO-400 of 2009 Dated:-24.12.2009 (NPS).
