Whereas CMO Anantnag vide his letter No:-Est/III/Compt/Gen/6045-46 Dated:- 07.12.2019 has informed that one Junior Pharmacist namely Mr. Farooq Irfan Block Bijbehara is absconding from his legitimate duties w.e.f. 05.08.2019. The concerned BMO has called explanation vide his No:-Est/BMO/Bij/619 Dated:- 14.08.2019 to attend his legitimate duties within 24 hours but despite more than one month concerned Junior Pharmacist has not reported to his duties and

Whereas the CMO Anantnag was asked to furnish full service records of the aforementioned Jr. Pharmacist viz-a-viz Ist appointment order copy Photostat & copy of service book duly attested by concerned DDO vide this office letter No:-Est-II/NG/PF/489/139 Dated:-12.02.2020. Accordingly CMO Anantnag vide his letter No:-Est/III/Gen/PF/8321-22 Dated:- 25.02.2020 has furnished the requisite documents and

Whereas the case has been examined in this Directorate & CMO Anantnag was directed to serve Show cause notice above named official in his home residential address and get the same published in prominent leading news paper from Kashmir Division where under opportunity be granted to him for resuming duties back vide his office letter No:-Est-II/PF/Phar/489/300 Dated:- 20.03.2020 and


Whereas CMO Anantnag vide his letter No:-Est-II/Gen/PF/1248-49 Dated:- 02.06.2020, has intimated that BMO Bijbehara vide his letter No:-Est/BMO/Bij/190 Dated:- 27.05.2020, has issued show cause notice/final notice & has been published to daily news paper "SRINAGAR TIMES" on 17.05.2020 & same has also been sent to his residential address of the concerned Junior Pharmacist by registered post on 27.05.2020 but till date the said official has not reported his duties and

Whereas in reply the CMO Anantnag was asked to issue one more show cause notice be served to him on home address on his home address & publish the same in two leading news paper from Kashmir Division with the directions to join back duties within weeks time positively failing which action shall be initiated against him as per norms in vogue vide this office letter No:-Est-II/PF/Phar/489/860 Dated:- 17.06.2020 and

Whereas CMO Anantnag vide his letter No:-Est-II/Gen/PF/3017-18 Dated:- 18.07.2020, has issued final show cause notice & got published into two daily news papers of Kashmir Division viz. "RISING KASHMIR AND "SRINAGAR TIMES" on 05.07.2020. Moreover the concerned Junior Pharmacist was directed to resume his

duties within 07, days from the date of publication of final notice but he has not resumed his duties and

Whereas the CMO Anantnag was asked one more opportunity may be given to aforementioned absconding Junior Pharmacist to issue final show cause notice the same be published in any two leading news paper from Kashmir valley so that further action shall be initiated against him as per norms in vogue vide this office letter No:- Est-II/PF/Phar/489/1218 Dated:- 22.08.2020 and

Whereas in reply CMO Anantnag vide his letter No:-Est/III/Gen/PF/6035-36 Dated:-09.11.2020 has informed that 3rd final Notice to the concerned Junior Pharmacist who is absconding w.e.f. 05.08.2019 has been got published into two daily news paper of Kashmir valley viz."KASHMIR IMAGES" and daily "SRINAGAR TIMES" on 06.11.2020 & copy of same send to his home address through registered post but he fails join duties and

Whereas the enough opportunities haven been granted to Mr.Farooq Irfan Junior Pharmacist Block Bijbhera District Anantnag to resume his duties but he fails to do so.

Now therefore the services of Mr.Farooq Irfan Junior Pharmacist Block Bijbehara District Anantnag is hereby terminated from the date of his unauthorized absence from legitimate duties viz.05.08.2019 in terms of Article of 128 J&K CSR.
