Subject: - Compassionate appointment case of Mr. Suhail Rashid S/O Late Haroon Rashid Zargar (Deceased Basic Health Worker) R/O:-Mohalla Shakaz Kadipora Anantnag in terms of SRO- 43 of 1994

Whereas, Chief Medical Officer Anantnag vide Letter No:-Est/BHW/171-72 Dated:- 08.04.2013, forwarded and recommended the compassionate appointment case of Mr. Suhail Rashid S/O Late Haroon Rashid Zargar R/O:-Mohalla Shaksaz, Kadipora Anantnag who was working as Basic Health Worker in the office of Chief Medical Officer Anantnag and had died in harness on 18.02.2013 during active service as per the Death Certificate issued by the Registrar Birth and Death Anantnag Municipal Council in terms of Registration No.33 Dated:-26.02.2013 alongwith connected documents for his appointment on compassionate grounds under SRO -43 of 1994 in place of his deceased father.


Whereas, as per the Dependent Certificate issued by the Additional Deputy Commissioner Anantnag vide his office No.292/LH/Dep/SRO-43 Dated: 28.03.2013, the deceased Basic Health Worker is survived by the following dependents at the time of his demise:-

Whereas, the aforementioned legal heirs of the deceased Basic Health Worker appearing at S No. 01 & 03 have tendered affidavits duly attested by Judicial Magistrate IST Class Anantnag Kashmir, to the effect that they have no objection in case S No. 02 namely Suhail Rashid S/O:- Haroon Rashid Zargar R/O:-Mohalla Shaksaz, Kadipora Anantnag is appointed in terms of SRO 43 of 1994.

Whereas, the S No.01 namely Shahzada Akhter M/O: - Suhail Rashid being legal guardian of her son has also tendered an affidavit on behalf her son duly attested by Judicial Magistrate Ist Class Anantnag Kashmir, to the effect that in case her son is appointed under SRO 43, he will look after, serve and will take care of the family members of the deceased Basic Health Worker and in case, he fails to do so, his appointment under SRO 43 shall be automatically deemed to have been cancelled abintio.

Now, therefore, as per the submission/recommendation made by the Chief Medical Officer Anantnag vide No. Est/BHW/171-72 Dated:-08.04.2013 coupled with Administrative Department H&ME Letter No.HD/NG/209/2013 Dated:-15.01.2018 and pending verification of his credentials and Character Antecedents from respective quarters, Mr. Suhail Rashid S/O



Late Haroon Rashid Zargar R/O Mohalla Shaksaz, Kadipora Anantnag is hereby appointed as Nursing Orderly (Class IVth) on compassionate grounds under SRO 43 of 1994 in the pay scale of Rs. 4440-7440 with Grade Pay of Rs. 1300 (Pre-Revised) plus usual allowances as admissible under rules against an available lien free vacancy in District Anantnag as identified by Chief Medical Officer Anantnag in terms of communiqué No.Est/III/SRO-43/11662 Dated:-26.02.2018, with the condition that he will look and serve after the dependents of his deceased father. In case, he violates terms & conditions of the affidavit furnished by her mother on his behalf as being lawful guardian of him, his services shall be terminated from abinitio without any notice.

The Chief Medical Officer Anantnag will allow the appointee to join within 21 days from the date of issuance of this order, only on production of the following documents in duplicate which shall be self attested by applicant himself, and Chief Medical Officer Anantnag shall not draw and disburse the salary of the appointee unless and until report regarding his character antecedents is received from the office of Additional Director General of Police CID J & K and other verification reports of requisite documents viz D.O.B & PRC are received from concerned quarters to whom references have already been made by this Directorate.
