Whereas, a selection list of below mentioned candidate as "Jr. Theatre Technician District Cadre Kulgam was received by this office through Administrative Department vide their letter No:- HD/NG/247/2018 Dated:- 15-05-2019 for issuance of formal appointment order in his favour.

Whereas, the recommendation of the said candidate was earlier kept withheld by the J&K SSB for want of certain clarification which has now been released by J&K, SSB vide their letter No. SSB/Secy/Sel/ 2018/2237-38 Dated: - 25.03.2019, in favour of concerned candidate conveyed by the Administrative Department vide their above mentioned communication.

Whereas, the said candidate has submitted his requisite original certificates alongwith affidavit duly attested by Judicial Magistrate, 1<sup>st</sup> Class, Srinagar to the effect that he shall be liable for termination of his appointment in case any thing adverse is reported against him from any of the verifying agencies including character/ antecedents from CID, J&K.

Now, therefore, pending verification of his testimonials/ Character antecedents from the concerned verifying agencies, the below mentioned candidate is hereby appointed on regular/ temporary basis as "**Jr. Theatre Technician**" in District Cadre Kulgam under RBA category in the pay level 4 (25500-81100) in terms of SRO 202 Dated:- 30-06-15 against the vacant post of "Jr. Theatre Technician" as shown against him.

**The appointment shall be subject to the following terms & conditions.**

1. The arrangement, if any, made against the said post(s) shall be simultaneously withdrawn and appointee(s) adjusted.
2. The appointment in District cadre/ Divisional Cadre is non-transferable from one District/ Divisional cadre to another District/ Divisional cadre.
3. The appointee shall be on probation for a period of 5 years, which shall have to be completed satisfactory.

4. The salary of the appointee shall not be drawn and disbursed to him/her till genuineness of his/her character and antecedents are received from CID and other agencies.
5. If on verification, character and antecedents of the appointees are found adverse or the certificates produced by the appointee are proved fake or forged, his appointment shall be deemed to have been cancelled ab-initio without any further notice.
6. The appointee shall report to Chief Medical Officer Kulgam within 21 days from the date of issuance of order failing which his appointment shall be cancelled ab-initio without any further notice.
7. The appointment of the official is governed under SRO 202 Dated:- 30-06-2015
8. The order issued is without prejudice to the outcome of any petition pending in any competent court of Law.
9. Verification of the recognition status/ genuineness of qualification/ category certificate/ permanent Resident certificate/ Domicile Resident of concerned District for a period not less than 15 years except schedule caste category shall be made confidentially by the indenting department from the concerned Universities/ Institutions/ Departments and in case, any certificate/ documents during the course of verification turn out to be the fake/ factious, the Department may kindly be kept posted with such outcome so that Criminal proceeding against such candidate are initiated.
