For and on behalf of Governor of J&K State, sealed Tenders superscribed with ("**Tender for Dietary items for Leper inmates for the year 2017-18**") affixed with **Rs.5/-** Revenue stamps are invited from the Registered Dealers/Suppliers/Contractors of the Valley for supply of Dietary and other Common Items (on daily basis) as per Sample to be provided for the items listed in Annexure –A and Annexure-B of this NIT, for inmates of Leper Hospital Srinagar for the year 2017-18 which is likely to be scattered during 2018-19 till new tenders are invited and rates finalized.

The tenders should be addressed to the Chief Medical Officer Srinagar and accompanied with the Security Deposit to the tune of Rs.1,00,000/- (Rupees One Lac) for **Group =A** items and Rs.50,000/= (Rupees Fifty thousand only) for **Group=B** items in the shape of CDR/FDR from any nationalized bank/JK Bank having validity not less than 24 months from the date of issue and pledged to the Chief Medical Officer Srinagar. The Security Deposit of previous undecided tenders received vide this office No.CMO/S/2017-18/Leper/1409-12 dated:21.06.2017 can be considered for this NIT if any one of them intends to participate now. Thus in such case/s the concerned tenderers need not to submit fresh Security Deposit for this NIT.

The Tenders complete in all respects **should reach the office of the undersigned by or before 07.12.2017** upto 2:00 P.M and **will be opened on 11.12.2017 at 2.30 P.M** in presence of the intending tenderers or their representative, who wish to be present at the time of opening. In case the date of opening happens to be off day due to any reason, the same will be opened on the next working day at the same time.

The detailed Tender Notice and the List of items / articles of Group "A" & "B" **can be had from office of the undersigned upto 04.12.2017** during office hours on all working days against the cash payment of Rs.500/=(Non refundable) for which necessary G.R will be issued by this office. The samples of the items (wherever applicable) are to be deposited while submitting the tender for items quoted by the tenderers. All the items are to be approved/finalized as per Sample to be submitted. The required sample should be kept in sealed Transparent Polythene Cover mentioning with S.No. of the item & name of the item having proper seal and signature of the concerned tenderer. The same should be pasted both on Outer Cover and on Sample (wherever applicable). Tenders without sample/s (wherever applicable) shall not be accepted.

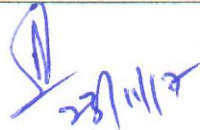

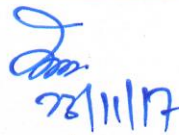
