Whereas, the Medical Superintendent District Hospital Pulwama vide communication No.MS/DH/P/Acctt/8173 Dated:-09.02.2018 forwarded the case of one Mr. Naseer Ahmad Pandit I/C Theatre Technician District Hospital Pulwama for grant of 2nd Time Bound Insitu Promotion from 01.10.2011. The case was received in this office along with all allied documents including original service records of the official.

Whereas, during the processing of the case it came to fore that the above named official has joined the department as on 07.02.1980 to the post of Nursing Orderly in the pay scale of Rs. 170-2-186-4-230 (pre-revised) after being appointed in terms of order No.Est-I/151 Dated:-04.02.1980 by Chief Medical Officer Pulwama.

Whereas, the said official has been granted first Functional Promotion as Junior Pharmacist in the pay scale of 1200-2040(pre-revised) w.e.f 22.09.1993 in terms of this office Order No.Est-I/promotion-class iv/16239-41 Dated:-10.01.1995 and subsequently he was granted First Insitu Time Bound Promotion in the pay scale of 4500-125-7000(pre-revised) by Chief Medical Officer Pulwama in terms of his Order No.CMO/Pul/Acctt/460 Dated:-25.04.2003 w.e.f 01.10.2002.

Whereas, afterward he was granted Second Functional Promotion in his Own Pay and Grade (OPG) with charge allowance to the post of Jr. Theatre Technician in terms of this office Order No.172/NG of 2009 Dated:-29.06.2009 subject to the pending approval and confirmation by Departmental Promotion Committee.

Whereas, the case was examined, discussed threadbare in this office and it was found appropriate that the official would be granted 2<sup>nd</sup> Insitu Time Bound Promotion from the date he was entitled for the same viz 01.10.2011 and the Functional promotion so granted in his favour in terms of this office order No.

172/NG of 2009 as I/C Jr. Theatre Technician shall be forfeited/ceased with immediate effect.

Now, therefore, it is hereby ordered that the case of the official for grant of 2nd Insitu Promotion (TBP) from 01.10.2011 shall be placed before the DPC committee constituted for the purpose for clearance/confirmation and in the meanwhile the benefit of Functional Promotion as I/C Jr. Theatre Technician already granted in favour of the official in terms of this office order No. 172/NG of 2009 Dated:-29.06.2009 is forfeited/ceased with immediate effect and the concerned DDO shall ensure that necessary rectification/entries are made in the service book of the official with regard to re-fixation of pay etc. and shall ensure recovery of Charge Allowance if any drawn by the official concerned.
