In terms of J&K Compassionate Appointment rules, 1994 notified vide SRO- 43 dated 22/02/1994, Sanction is hereby accorded to the temporary appointment of Mr. Arshid Ahmad Dar S/o Late Mehraj-ud-Din Dar (Ex- Health Educator) R/o Azad Basti Natipora, Srinagar as Junior Assistant, in the Pay Band of Rs. 5200-20200 with the Grade Pay of Rs. 1900/- in the Directorate of Health Services Kashmir in relaxation of technical qualification (i.e. type knowing and six months computer course) in terms of Rule-7 of SRO-43 of 1994.

5. Dependent certificate issued by the Competent Authority.
6. All other relevant documents as required under SRO-43 of 1994.

- b) Verification of the qualification/date of birth certificate and reserved category certificate (if applicable) from the concerned issuing authorities. If on verification the certificates produced by the appointee are proved fake or forged, the appointment shall be cancelled *ab-initio*.

Salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of (a) and (b) above is received.

The appointee shall be on probation for a period of two years. His appointment shall be governed by the provisions of SRO 400 of 2009 dated 24/12/2009 issued by the Finance Department.
