Subject- Reinstatement of Services in respect of Mr. Abdul Rashid Reshi Health Educator Block Tangmarg District Baramulla.

ORDER NO: - 644/NG OF 2018

Whereas, Mr. Abdul Rashid Reshi Health Educator Block Tangmarg was placed under Suspension for his alleged misconduct and resorting to unauthorized absence from legitimate duties in terms of this Office Order No.533/NG of 2018 Dated:- 18.07.2018 issued under endorsement No.Est-II/NG/32/HD/3146-54 Dated:- 18.07.2018 and subsequently an enquiry was order into the matter.

Whereas, the enquiry committee served charge sheet upon the above said employee on his residential address vide No.Est-II/NG/HE/32/3168-72 Dated:-20.07.2018 wherein he was asked to submit response/reply in his defence within a period of 07 days failing which action as warranted under rules was intimated to be followed.

Whereas, in the meanwhile the said official approached the Hon'ble High Court J&K Srinagar through the medium of SWP No.1670/2018 titled Abdul Rashid Reshi Vs. State of J&K & Ors. Challenging therein order of suspension of the petitioner issued by this Directorate. The Hon'be High Court interms of Order Dated:- 24.07.2018 passed following interim directions which read as, "In the meantime, subject to objections from the otherside and till next date of hearing before the Bench, the order to the extent of attaching the petitioner with the office of Block Medical Officer, Tanghdar, and Kupwara shall stay."


Whereas, during the pendency of the writ petition, the said official submitted reply to the chargesheet along with an undertaking to the extent that he will seek prior permission from the competent authority for proceeding for any interstate or otherwise training programme as and when deputed or asked to conduct any training course by any authority from H&ME Department. Further solicited that he has equal respect for all the Directors of H&ME Department and always shall maintain required protocol at various levels being governed by CSR as an employee and submitted unconditional apology for his misconduct.

Whereas, the said official was allowed by the Block Medical Officer Tangmarg to resume his duties at SDH Tangmarg in pursuance of the Hon'be High Court Orders and reportedly official is continuing at the said institution.

Whereas, the reply as well as the undertaking submitted by the official was examined and it has been observed that the official has submitted unconditional apology that he will abide by the orders/directions of the higher authorities and will never act against the norms and regulations in vogue. Besides has submitted that in future he will remain

careful, obedient and law abiding employee of the department. In case he violates norms in future, his services shall be terminated.

Now, therefore, in view of the details given hereinabove coupled with unconditional apology tendered by the official and Sub Rule (3) of Rule-31 J&K Classification Control and Appeal Rule of 1956, Mr. Abdul Rashid Reshi Health Educator Block Tangmarg presently under suspension is reinstated with immediate effect with the directions to report to new place of posting viz Block Medical Officer Kunzer District Baramulla for further duties. However, the intervening period spent by the official on suspension shall be decided separately.
