Now, therefore, in view of the submissions/recommendations made by Chief Medical Officer Kupwara in terms of aforementioned letter dated: 28.10.2020 Mr. Salman Shahbaz Dar S/O Late Mohd Shahbaz Dar R/O Kawari Kupwara is hereby appointed as "Attendant" on regular temporary basis on compassionate grounds under SRO 43 of 1994 in the Pay Level SL-1 (14800-47100) plus usual allowance as admissible under rules, against an available vacancy in Block Kupwara subject to condition that he will look after and serve the dependents of his deceased mother and in case he violates terms and conditions of the affidavit submitted/ solicited by him in this Directorate, his services shall be terminated abintio without any notice.

"The salary of the candidate shall not be released unless authentication of verification of his certificates alongwith his character/ antecedent & until the certificate are received from the concerned verifying agency as well as Additional Director General of Police CID Jammu/ Srinagar. In case any certificate(s) produced by the applicant are proved fake/ forged, his appointment order shall be deemed to be cancelled ab-intio:

The Chief Medical Officer Kupwara will allow the appointee to join within 21 days from the date of issuance of this order only after the production of following documents in original, in case he fails to join within the stipulated time his appointment order shall be cancelled without any further notice. The appointment of the appointee shall be governed under the provisions of SRO 400 of 2009 dated:31.12.2009 New Pension Scheme (NPS) and the appointee shall be on probation for a period of two years:-

- 01. Academic Qualification Certificate.
- 02. Date of Birth Certificate (10th)
- 03. Domicile Certificate.
- 04. Health Certificate from the Chief Medical Officer Kupwara.

- 05. Dependent / Legal Heir Certificate issued by the Assistant Commissioner, Revenue.
- 06. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
- 07. Un-employment Certificate from District employment Exchange.
- 08. All other relevant documents as are required under SRO-43 of 1994 and other Acts/Rules presently in vogue on the subject.
