Whereas a team of officers headed by Assistant Director Health Services Kashmir of this Directorate visited District Hospital Budgam on 3rd April 2019 at 5:50 PM & inspected different sections of the Hospital.

Whereas while during the inspection of various sections viz-a-viz Sanitation, Dispensary & Stores of the Hospital it has been found that the poor and dismal conditions of these sections & also expired drugs recovered by the Inspection team from stores which is in gross violation of norms & other procedures.

Whereas taking the cognizance of the matter by the authorities accordingly the following officials of DH.Budgam were placed under suspension with immediate effect vide this office order No:- 240/NG of 2019 Dated:- 10.04.2019, issued under endorsement No:-Est-II/NG/Gen/165/7482-89 Dated:- 10.04.2019 & attached to Directorate of Health Services Kashmir.

Whereas the charge sheet served in favour of above named officials vide this office No dated:- 22.04.2019 with the directions to explain their positions in the form of a written statement their reply should reach to this Directorate within 07, days from the date of issuance of charge sheet failing which it will be presumed that they have nothing to say in their defense and thereafter further action as warranted under rules shall be initiated against them.

Whereas in response to charge sheet the aforementioned officials have given the reply of charge sheet & also tendered an affidavit to the effect that these mistakes have been committed by them either voluntarily or by negligence they have apologized for the same & will not repeated such mistakes in future.
