Furthermore the placement as I/c Sr. Pharmacists shall be subject to the seniority of officials as determined in final seniority list of Jr. Pharmacists and the promotees shall not have any superior claim for regularization/regular promotion whenever the same are made.

The aforementioned officials shall join at new place of posting within 07, days from the date of issuance of this order failing which the promotion order shall be cancelled ab-initio. Besides the Chief Medical officers shall ensure that no attachment is made without prior approval of Director Health Services Kashmir & submit compliance report to this Directorate within 15, days to the effect that all promotees have joined physically at their new place of postings.

The left out Junior Pharmacists as per the seniority list shall submit the requisite documents within 15, days from the date of issuance of this order failing which the next incumbent shall be promoted without further notice.
