Sub:- Re-instatement of Block Medical Officer Shopian & other staff.

ORDER NO: 289 /NG of 2019.
DATED: 01 / 05 / 2019.

Whereas the Chief Medical Officer Shopian in terms of his office letter No:- BMO/SPN/EST/719-20 Dated:- 22.12.2018, has informed that one Pharmacist namely MukhtarAhmad Shah Jr.Pharmacist had applied for 07 days casual leave on medical grounds w.e.f. 15.11.2018 which was sanctioned by BMO Shopian and the official was supposed to resume his duties w.e.f. 22.11.2018 but instead of joining back to his duties he remained on unauthorized absence from the said date and submitted leave application for extension of his leave on medical grounds without submitting supportive medical grounds.

Whereas, accordingly taking cognizance of absence of the said official BMO Shopian served a notice at the residential address of the pharmacist with the directions to resume to the duties but he has given no response.

Whereas Chief Medical Officer Shopian vide letter No:-CMO/SPN/Phar/3035-36 Dated:- 11.01.2019 apprised this Directorate and submitted BMO Shopian report with regard to the unauthorized absence of aforementioned Jr.Pharmacist.

Whereas no instructions/orders were issued from this Directorate either to Chief Medical Officer Shopian nor to BMO Shopian with regard to unauthorized absence of the said Pharmacist.

Whereas without keeping into consideration the rules governing in the field BMO Shopian has allowed the Pharmacist to resume his duties on 15.04.2019 at his own level vide his order No:-BMO/SPN/Est/42-44 Dated:- 15.04.2019 subject to pending settlement of unauthorized absence period.

Whereas in the meantime Chief Medical Officer Shopian in terms of his office communication No:- CMO/Spn/Phar/234-35 Dated:- 24.04.2019 apprised about the joining of Jr.Pharmacist and endorsed the order of BMO Shopian Dated:- 15.04.2019 to this Directorate for information & necessary action.

Whereas this Directorate taking strict cognizance of the matter placed under suspension BMO Shopian & his Dealing Assistant vide this office order No:- No:- 259/NG of 2019 Dated:- 14.05.2019, as BMO Shopian has allowed the said Pharmacist rejoining at his own level such matter are to be dealt within the competent of Director Health Services Kashmir being the competent authority as well as appointing authority in respect of non-gazetted cadre.

Whereas charge sheet has been served to BMO Shopian & his Dealing Assistant to explain their position how BMO Shopian has allowed the official to resume his duties without seeking proper approval from this Directorate their reply should reach to this Directorate within 01 day positively from the date of issuance of this charge sheet failing which it will be presumed that you have nothing to say in their defense and thereafter further action as warranted under rules shall be initiated against them vide this office No:-Est/II/477/JP/7718-22 Dated:- 20.05.2019.

In response to charge sheet Dr.Mohammad Yousuf Naikoo I/c BMO Shopian has given reply of charge & has intimated that he has recently promoted/posted as I/c BMO Shopian & he is not so much familiar with rules and regulations & he has tendered an apology for committing a mistake for allowing the Jr.Pharmacist to resume his duties in BMO office Shopian without seeking approval from higher authorities pending settlement of his un-authorized absence & Mr.Mohammad Maqbool Malla Sr.Assistant has given the reply of charge sheet & has intimated that he was not fully aware of un-authorized absence case of with the result the concerned Pharmacist has been allowed to join in the department without seeking approval from higher authorities.

Keeping view of reply submitted by the BMO Shopian & his Dealing Assistant it is hereby ordered that the services of Dr.Mohammad Yousuf Naikoo I/c BMO Shopian & Mr.Mohammad Maqbool Malla Sr.Assistant Block Shopian is hereby re-instated, the suspension period w.e.f. 14.05.2018 till date is treated as duty. The said officer/official is warned to remain careful in future not to repeat such practices in future.
