Whereas, the Block Medical Officer, Uri placed you under suspension vide Order No.Est/BMOU/183-85 Dated:- 25.06.2015 in compliance to the instructions conveyed to him by the then Chief Medical Officer, Baramulla during his visit to SDH Uri on 25-06-2017 and you were accordingly relieved on the same day with the directions to report Chief Medical Officer's office Baramulla for further duties.

Whereas, in terms of order No:- 1785-87 Dated:- 29.06.2015 of the Chief Medical Officer Baramulla, you were deemed to have been relieved to this Directorate with immediate effect, pending inquiry into the matter, and non-compliance of orders.


Whereas the action taken by Chief Medical Officer Baramulla was confirmed by this Directorate vide this office order No:- 305/NG of 2015 Dated:- 08.10.2015, issued under endorsement No:- Est-5/NG Dated:-08.10.2015 and the said order was passed in deference to the order/ judgment dated 16-07-2015 of the Hon'ble High Court, Srinagar delivered in SWP No.1489/2015 which was filed by you.

Whereas, as per the directions contained in the aforesaid judgment of the Hon'ble High Court, Srinagar dated 16-07-2015 and subsequent decision taken by this office vide order dated 08-10-2015, you have not right to be allowed to continue in SDH Uri, Baramulla.

Whereas despite lapse of considerable time, you have not joined in this Directorate till date instead resorted to un-authorized absence and you should note that un-authorized absence from duties tantamount to loss of appointment in terms of Article 128 of J&K CSR.

Whereas, your whereabouts are not known to this office since you stands relieved from SDH Uri, Baramulla besides you have not applied for any kind of leave as per the rules or sought any kind of permission from the competent authority.

Now, this show cause notice is served upon whereby you are extended final opportunity to explain your position for non-compliance of orders and also resorting to un-authorized absence from duties without any kind of leave / permission. Your reply shall reach in this office within three days positively, from the date of issuance of this notice, failing which, it shall be presumed that you are not interested to serve in the department and action under Article 128 of J&K CSR shall be initiated against you for resorting to authorized absence. //
