3. The appointee shall be on probation for a period of two years.
4. The salary of the appointee shall not be drawn and disbursed to him till genuineness of his character and antecedents are received from CID and other agencies.
5. If on verification, character and antecedents of the appointee are found adverse or the certificates produced by the appointee are proved fake or


- forged, his appointment shall be deemed to have been cancelled ab-initio without any further notice.
