Whereas, this office has received the compassionate appointment case of Mr. Aftab Ahmad Sheikh S/O Bashir Ahmad Sheikh deceased safaiwalla R/O Humhama District Srinagar vide Chief Medical Officer, Srinagar letter No. CMO/sgr/6921 dated 22-3-2017 for consideration of his appointment under SRO 43.

Where as, father of applicant namely Bashir Ahmad Sheikh deceased was working as safaiwalla in Chief Medical Officer, District Srinagar, on regular establishment who died in harness on 11-12-2016, as per the death certificate issued by the Registrar Births and Deaths Srinagar Municipal Corporation.

Whereas, as per dependence certificate issued by the Assistant Commissioner,(Rev) Budgam Vide his No. DCB/Relief/2017/966 dated 28-1-2017 the deceased has left behind the following dependents:-

Whereas, the Dependent No.1,2,4,5,6,7,8 have submitted an affidavit duly attested by Judicial Magistrate 1st class Budgam to the effect that they have no objection if dependent No. 3 Mr. Aftab Ahmad Shiekh S/O Bashir Ahmad Shiekh deceased Safaiwalla is appointed in terms of SRO 43 on compassionate grounds.

Whereas, the Dependent No. 3 has also submitted an affidavit duly attested by the Judicial Magistrate 1st class Budgam to the effect that he will look after the other dependents of deceased on availing the benefit of appointment.

Whereas, the requisite certificates have been got verified and nothing has been reported adverse.

Now therefore, keeping in view the position given here in above, sanction is hereby accorded to the appointment of Mr. Aftab Ahmad Sheikh S/O Bashir Ahmad Sheikh deceased Safaiwalla R/O Humhama District Srinagar on regular temporary basis on compassionate grounds in terms of SRO 43 of 1994, against the post caused vacant at District Srinagar due to the death of his father in the pay band of 4440-7440 with grade pay of Rs. 1300.

The applicant shall join in the office of Chief Medical Officer, Srinagar within a period of 21 days subject to the following conditions and production of required certificates

- a. State subject certificate.
 - b. Qualification certificate.
 - c. Non-Loanee Certificate.
 - d. Legal heir
- a. The chief Medical officer, Srinagar shall not draw his salaries until and unless the verification report with regard to character/ antecedents is received from concerned agencies.
 - b. The appointee shall be on probation for a period of (02) years which he should have to complete satisfactory.
 - c. That the appointee will look after the family left behind by the deceased as per affidavit submitted by him. In case any thing adverse is reported and proved the appointment shall be treated as cancelled.
