**NOTICE**

Whereas, the Administrative Department Health & Medical Education vide letter No. HD/NG/86/2017 Dated: 21/04/2017 forwarded the select list of Eighteen (18) candidates, 11 under OM category, 04 under RBA, 01 under ST & 02 under SC for the post of **Health & Family Welfare Assistant (Health and Medical Education Department)** District cadre Kupwara whereunder the selection of Five (05) selected candidates were kept withheld.

Whereas, the Administrative Department Health & Medical Education vide letter No.HD/NG//86/2017 Dated:-20.07.2017 released recommendation in favour of all the Five (05) selected candidates.

Whereas, the case was processed and the formal appointment orders were issued in respect of all the (05) candidates whose candidatures were initially kept withheld by Services Selection Board J&K figuring in the selection list at **S.No.03, 06, 07 & 09 under OM category and S.No.03 under RBA Category** vide this Directorate Order No.348/NG of 2017 Dated:-19.08.2017 issued under endorsement No.Est-II/Sel/2017/H&FW Asst/Recommendation/1533-40 Dated:-19.08.2017 with the directions to join their postings within period of 21 days from the date of issuance of formal appointment order in their favour failing which their appointment shall be deemed to have been cancelled ab-initio without any further notice.

Whereas, Chief Medical Officer Kupwara in terms of his comminque No.CMOK/Estt/3637 Dated:-12.09.2017 intimated that in pursuance of aforementioned Formal Appointment Order Dated:-19.08.2017, one candidate namely Sajad Ahmad Mir S/O: - Abdul Aziz Mir R/O:-Ashipora Tehsil Handwara District Kupwara did not join at CMO Office Kupwara nor at the proposed place of posting i.e S/C Kuchban Jumgand Block Trehgam even after expiry of stipulated time.

Whereas, Accordingly Sajad Ahmad Mir S/O:-Abdul Aziz Mir R/O:-Ashpora, Tehsil Handwara, District Kupwara selected candidate figuring in the selection list at **S.No.06 under OM Category** and in whose favour Appointment Order was issued by this Directorate vide aforementioned Order Dated:-19.08.2017 has furnished an Affidavit/Undertaking in this Directorate duly attested by Executive Magistrate 1st Class Srinagar wherein he has stated that he is not interested for the Post of "**Health and Family Welfare Assistant**" and solicit that the contents are based on facts and if found fake he shall be personally /legally responsible for the consequences and in addition solicit this affidavit/undertaking before authorities of this Directorate that he is not interested to join the job.


Now, therefore, in view of the above noted details, the appointment of Sajad Ahmad Mir S/O:-Abdul Aziz Mir R/O:-Ashpora, Tehsil Handwara, District Kupwara for the post of "**Health and Family Welfare Assistant District Cadre Kupwara**" is hereby cancelled.
