Subject: Compassionate appointment case of Tariq Amin Shah S/O Late Mohammad Amin Shah R/O Villagam Kupwara in terms of SRO 43.

Whereas, Chief Medical Officer Kupwara vide office letter No:-Est/III/376-77 Dated:-29.04.2017, forwarded and recommended the compassionate appointment case of **Tariq Amin Shah S/O Late Mohammad Amin Shah** who was working as Sr. Pharmacist in District Kupwara and had died in harness on 06.02.2017 during active services as per the Death Certificate issued by the Police Station Vilgam, alongwith connected documents for his appointment on compassionate grounds under SRO -43 in place of his deceased father.

Whereas, as per the Dependent Certificate issued by the Additional Deputy Commissioner Handwara vide his office No.ADC/R/17/343 Dated: 17.03.2017, the deceased pharmacist is survived by the following dependents at the time of his demise:-

Whereas, the aforementioned legal heirs of the deceased Senior Pharmacist appearing at S No. 01, 02 & 04 have tendered affidavits duly attested by Judicial Magistrate IST Class Handwara Kashmir, to the effect that they have no objection in case S No. 03 namely Tariq Amin Shah is appointed in terms of SRO 43.

Whereas, the S No 03 namely Tariq Amin Shah S/O Late Mohammad Amin Shah has also tendered an affidavit duly attested by Judicial Magistrate Ist Class Handwara, to the effect that in case he is appointed under SRO 43, he will look after and serve the family members of the deceased pharmacist and in case, he fails to do so, his appointment under SRO 43 shall be automatically cancelled.

Now, therefore, as per submission/recommendations made by the Chief Medical Officer Kupwara vide No. Est/III/376-77 Dated:-29.04.2017, Mr. Tariq Amin Shah S/O Late Mohammad Amin Shah R/O Villagam Kupwara is hereby appointed as Nursing



Orderly (Class IVth) on compassionate grounds under SRO 43 in the pay scale of Rs. 4440-7440 + 1300 (Grade pay) plus usual allowances as admissible under rules against an available vacancy in District Kupwara, with the condition that he will look and serve after the dependents of his deceased father. In case, he violates terms & conditions of the affidavit, his services shall be terminated from Govt. services.

The Chief Medical Officer Kupwara will allow the appointee to join within 21 days from the date of issuance of this order, only on production of the following documents in original, failing which action as warranted under norms will be taken and shall not draw the salary of the appointee unless the antecedents/character certificate is received by the office from Additional Director General of Police CID J & K:-

1. Qualification Certificate
2. Date of Birth Certificate
3. State Subject Certificate
4. Non Loan Certificate from D I C
5. Non Employment Certificate from District Employment Exchange
