Whereas, a selection list of below mentioned candidates as "X-Ray Assistants", Divisional Cadre Kashmir was received by this office through Administrative Department vide their letter No: HD/NG/182/2017 dated: 05-09-2017 under the Hon'ble Prime Minister's Special Package for Kashmiri Migrants for issuance of formal appointment order in favour of selectees strictly in terms of SRO-412 dated: 31-12-2009.

Whereas, the recommendations of below mentioned candidates were earlier kept withheld by the J&K SSB for want of bonafide certificates of Diploma and recognition of Institute and now the recommendations have been released by J&K, SSB vide their letter No: SSB/Secy/Sel/X-Ray/Mig/2017/6038-40 dated: 12-07-2017 in favour of concerned candidates.

Whereas, the said candidates have submitted their requisite original certificates alongwith affidavits duly attested by Special Mobile Judicial Magistrate Passenger Tax Kashmir Province Srinagar and Sub Registrar Judicial Magistrate 1st Class Jammu to the effect that they shall be liable for termination of their appointment in case any thing adverse is reported against them from any of the verifying agencies including character/ antecedents from CID, J&K.

Now, therefore, pending verification of their testimonials/ Character antecedents from the concerned verifying agencies, the below mentioned candidate are hereby appointed on regular/ temporary basis as "X-Ray Technicians" in Divisional Cadre Kashmir in the pay band of Rs. (5200-20200) with grade pay of Rs.2400/- plus usual allowances as admissible under rules against newly sanctioned supernumerary posts under the Hon'ble Prime Minister's special package for Kashmir Migrants.

**The appointment shall be subject to the following terms & conditions.**

1. That the arrangement, if any, made against the said post shall be simultaneously withdrawn and appointee adjusted.
2. The appointment in District/ Divisional cadre is non-transferable from one District/ Divisional cadre to another District/ Divisional cadre.
3. The appointees shall be on probation for a period of two years, which shall have to be completed satisfactory.
4. The salary of the appointee shall not be drawn and disbursed to him till genuineness of his character and antecedents are received from CID and other agencies.
5. If on verification, character and antecedents of the appointees are found adverse or the certificates produced by the appointee are proved fake or forged, his appointment shall be deemed to have been cancelled ab-initio without any further notice.
6. A time of 21 days may be given to the appointees for joining and should be mentioned in the order itself that in case he/she fails to with this period, his/her appointment shall be deemed to have been cancelled ab-initio without an further notice.
7. The orders issued are without prejudice to the outcome of any petition pending in any competent court of law.
8. To verify the genuineness of Quantization/ category certificate/ PRC/ Domicile status of candidate viz-a-viz concerned district for a period not less than 15 years except schedule caste category. In case, any certificate/ documents during the course turn out to be the fake/ factious, the Administrative Department/ Service Selection Board be posted with such outcome so that Criminal proceeding against such candidate is initiated.
