Now, therefore, in pursuance of the recommendations made by the J&K Services Selection Board, J&K Jammu/Srinagar and as per the instructions/orders conveyed by the Administrative Department, Health and Medical Education Department under the above referred communications. Sanction is hereby accorded to the appointment of below mentioned candidates for the post of "Health and Family Welfare Assistant" District Cadre Kupwara at the place of postings shown against each on regular temporary basis in the pay band of Rs 5200 20200 with Grade Pay of Rs.2400. The appointment of the above named candidates is subject to following conditions as laid down in the Administrative Department, H & ME letter Dated: 21.04.2017.

1. The arrangements, if any, made against the said post will be simultaneously withdrawn and appointee adjusted.
2. The appointment in District/Divisional cadre is non-transferable from one District/Divisional cadre to another District/Divisional cadre.
3. The appointees shall be on probation for a period of two years.

4. The salary of the appointees shall not be drawn and disbursed to them till genuineness of their character and antecedents are received from CID and other agencies.
5. If on verification, character and antecedents of the appointees are found adverse or the certificates produced by the appointees are proved fake or forged, their appointment shall be deemed to have been cancelled ab-initio without any further notice.
6. The appointees shall join their duties within 21 days from the date of issuance of this order failing their appointment shall be deemed to have been cancelled ab-initio without any further notice.
7. The order issued is without prejudice to the outcome of any petition pending in any competent court of law.
8. The recognition status/genuineness of qualification/category certificates/permanent resident certificate/Domicile Resident of concerned district for a period not less than 15 years except SC Category shall have to be verified the indenting department confidentially from the concerned universities/institutions/departments and in case any certificate/document during the course of verification turns out to be fake/fictitious, the Administrative department may kindly be kept posted with such outcome, so that criminal proceedings against such candidates as initiated.
