Whereas, a revalidation of waiting list for the post of "Jr. Dental Technician" District Cadre Budgam, under SC category against item Item No: 356 of advertisement notice No: 06 of 2015 in terms of relaxation of rule 14(7), J&K, Civil Services (Decentralization) recruitment rules vide Govt order No: 27-HME of 2018 dated: 09-01-2018 issued under endorsement No: HD/NG/210/2016 dated: 09-01-2018 in favour of Janu Kaith S/o Palla Ram R/o Nagbani Smailpur, Jammu has been received from Administrative Department.

Whereas, Janu Kaith S/o Palla Ram R/o Nagbani Smailpur, Jammu, has tendered an affidavit duly attested by Sub Registrar Judicial Magistrate Ist Class Srinagar to the effect that he is already working as Jr. Dental Technician in District Cadre Srinagar as he is not interested to serve in District Budgam as Jr. Dental Technician.

Whereas, accordingly the matter has been taken with the Administrative Department vide this office letter No:Est-4/NG-367/68 dated: 19-01-2018 whereunder the request was made to authorize this Directorate to operate the waiting list against slot No: 01 under SC category in favour Shashi Bala W/o Tilak Raj R/o Raipur Satwari, Jammu who is figuring at S.No: 01 in the waiting list under SC category vide advertisement notice No: 06 of 2015 under item No: 356 in District Cadre Budgam.

Whereas, in reply the Administrative vide their letter No: HD/NG/210/2016 dated: 29-01-2018 conveyed the approval to operate the waiting list of the Jr. Dental Technician District Cadre Budgam in pursuance to notification No: 06 of 2015 under item No: 356 and in pursuance of Service Selection Board order No: 191-SSB of 2017 dated: 17-05-2017 issued by the J&K, SSB Jammu under endorsement No: SSB/Secy/Sel/56/2016/4806-08 dated: 17-05-2017.

Whereas, the said candidate has submitted the requisite original certificates alongwith affidavit duly attested by Sub Judge Special Mobile Magistrate Passenger Tax, Jammu to the effect that she shall be liable for termination of her appointment in case any thing adverse is reported against her from any of the verifying agencies including character/ antecedents from CID, J&K.

Now, therefore, pending verification of her testimonials/ Character antecedents from the concerned verifying agencies, the below mentioned candidate is hereby appointed on regular/ temporary basis as "Jr. Dental Technician" in District Cadre Budgam under SC category in the pay band of Rs.(5200-20200) with grade pay of Rs.2400/- plus usual allowances as admissible under rules against the vacant post of Jr. Dental Technician in District Budgam strictly in accordance to SRO-202 dated: 30-06-2015.

Her appointment shall be subject to the following terms & conditions as laid down under SRO-202 dated: 30-06-2015.

- 1. A person appointed under these rules shall be initially on probation for a period of five years.
- 2. The appointee shall have necessarily work for a period of five years on the post against which she has been appointed & such appointee shall not be eligible for transfer for whatsoever reason during the temporary service of five years. Provided that any person appointed against any available vacancy on the basis of being resident of backward area or an area adjoining line of actual control shall serve in such areas for a period of not less than seven years.
- 3. During the period of first five years, the appointee shall be entitled to minimum of scale of pay alongwith grade pay only applicable to the post against which she is appointed.
- 4. Every appointee shall after completion of five years period on probation be entitled to fixation of pay in the time scale of pay applicable to the post against which she is appointed.
- 5. She shall be entitled to annual increments, Dearness allowances, HRA & CCA after successful completion of her five years service on consolidated salary.
- 6. She shall be entitled to the benefits under the Medical attendance rules, & leave rules from the date of her 1st appointment itself.
- 7. The seniority of the person appointed under these rules shall reckon from the date of her appointment.

Sinor

 The period spent on probation/ consolidates salary shall also reckon for purpose of calculating the qualifying service of these appointees for pensioner & other benefits provided under rules.

Further, the appointment is also subject to the following conditions.

1. The arrangement, if any, made against the said post shall be simultaneously withdrawn and appointee adjusted.

The appointment in District/ Divisional cadre is non-transferable from one District/ Divisional cadre to another District/ Divisional cadre.

3. The appointees shall be on probation for a period of two years.

4. The salary of the appointee shall not be drawn and disbursed to him till genuiness of his character & antecedents are received from CID & other ageen

5. If on verification, character and antecedents of the appointees are found adverse or the certificates produced by the appointee are proved fake or forged, his appointment shall be deemed to have been cancelled abinitio without any further notice.

6. A time of 21 days may be given to the appointees for joining and should be mentioned in the order itself that in case he/she fails to with this period, his/her appointment shall be deemed to have been cancelled abinitio without an further notice.

7. The orders issued are without prejudice to the outcome of any petition

pending in any competent court of law.

8. Verification of the recognition status/ genuineness of qualification/ category certificates/ permanent resident certificate/ domicile resident of concerned district for a period not less than 15 years except schedule caste category shall be made confidentially by the indenting department from the concerned Universities/ Institutions/ Departments and in case any certificate/ document during the course of verification turns out to be fake/ fictitious, the Department may kindly be kept posted with such outcome so that criminal proceedings against such candidates are initiated.
