Whereas. the Administrative Department in terms of letter No. HD/NG/71/2018 dated 4-4-2018. has forwarded the selection list of a candidate for the post of Plumber. District cadre Kupwara. under SRO 202 dated 30-6-2015. issued vide communication No. SSB/Secy/Sel/2018/1630-37 dated 9-2-2018. of the J&K Service Selection Board with the advice to issue formal appointment order in favour of the selected candidate under open merit category under item No. 688 in pursuance to advertisement notice No. 07 of 2015 dated 2-12-2015.

Whereas. the said selected candidate has submitted the requisite original documents/certificates along with affidavit duly attested by Additional Special Mobile Magistrate 1st class Kralpora. to the effect that he shall be laible for termination of his appointment in case any thing adverse is reported against him from any of the verifying agencies including character/antecedents from CID. J&K.

Now therefore. pending verification of his testimonials. Character/antecedents from the concerned verifying agencies. the below mentioned candidate is hereby appointed on regular/temporary basis as "Plumber" in District cadre Kupwara. under OM Category in the pay band of Rs/- 5200-20200 with grade of Rs/- 2400+usual allowances as admissible under rules against the vacant post of Plumber as shown below strictly in accordance to SRO 202 dated 30-6-2015.

**His appointment shall be subject to the following terms and conditions as laid down under SRO-202 dated 30-6-2015.**

1. A person appointed under these rules shall be initially on probation for a period of five (05) years.
2. The appointee shall have necessarily work for a period of five years on the post against which he has been appointed and such appointee shall not be eligible for transfer for what so ever reason during the temporary service of five years. Provided that any person appointed against any available vacancy



on the basis of being resident of backward area or an area adjoining line of actual control shall serve in such areas for a period of not less than seven years.

3. During the period of first five years the appointee shall be entitled to minimum of scale of pay along with grade pay only applicable to the post against which he is appointed.
4. Every appointee shall after completion of five years period on probation be entitled to fixation of pay in the time scale of pay applicable to the post against which he is appointed.
5. He shall be entitled to Annual increments, dearness allowances, HRA and CCA after successful completion of his five years services on consolidated salary.
6. He shall be entitled to the benefits under the Medical attendance rules, and leave rules from the date of his first appointment its self.
7. The seniority of the person appointed under these rules shall reckon for purpose of calculating the qualifying service of these appointees for pensioner and other benefits provided under rules.

**Further, appointment shall be subject to following terms and conditions.**

1. The arrangements if any made against the said post will be simultaneously with drawn and appointee adjusted.
2. The Appointment in District /Divisional cadre is non-transferable from one district /division cadre to another district /divisional cadre.
3. The appointee shall be on probation for a period of five years .
4. The salary of the appointee shall not be drawn and disbursed to him till genuiness of his character & antecedents and received from CID and other agencies.
5. If on verification, character and antecedents of the appointee are found adverse or the certificates produced by the appointee are proved fake or forged, his appointment shall be deemed to have been cancelled abinitio without any further notice.
6. A time of 21 days may be given to the appointee for joining and should be mentioned in the order itself that in case he/she fails to with this period, his/her appointment shall be deemed to have been cancelled ab-initio without any further notice.
7. The orders issued are without prejudice to the outcome of any petition pending in any competent court of law.
8. Verification of the recognition status/genuiness of qualification/category certificates/permanent resident certificate/domicile resident of concerned district for a period not less than 15 years except schedule caste category shall be made confidentially by the intending department from the concerned universities/institutions/Departments and in case any certificate/document during the course of verification turns out to be fake/fictitious, the department may kindly be kept posted with such outcome so the criminal proceedings against such candidates are initiated


