Whereas, a selection list of below mentioned candidate as "Lab Assistant", Divisional Cadre Kashmir was received by this office through Administrative Department vide their letter No: HD/NG/162/2017-PF dated: 06-06-2018 under the Hon'ble Prime Minister's Special Package for Kashmiri Migrants.

Whereas, the recommendation of below mentioned candidate was earlier kept withheld by the J&K SSB for want of certain clarification and now the recommendation has been released by J&K, SSB vide their letter No: SSB/Secy/Sel/145/2017/1262-64 dated: 29-01-2018 in favour of concerned candidate.

Whereas, the said candidate has submitted the requisite original certificates alongwith affidavit duly attested by Judicial Magistrate 1st Class Qazigund to the effect that he shall be liable for termination of his appointment in case any thing adverse is reported against him from any of the verifying agencies including character/ antecedents from CID, J&K.

Now, therefore, pending verification of his testimonials/ Character antecedents from the concerned verifying agencies, the below mentioned candidate is hereby appointed on regular/ temporary basis as "Lab Assistant" in Divisional Cadre Kashmir in the pay band of (5200-20200) with grade pay of Rs.2400/- (pre-revised) plus usual allowances as admissible under rules against newly sanctioned superannuary posts under the Prime Minister's special package for Kashmir Migrants. The case is covered under NPS SRO-400 dated: 24-12-2009.

**The appointment shall be subject to the following terms & conditions.**

1. The arrangement, if any, made against the said post shall be simultaneously withdrawn and appointee adjusted.
2. The appointment in District/ Divisional cadre is non-transferable from one District/ Divisional cadre to another District/ Divisional cadre.
3. The appointees shall be on probation for a period of two years.

4. The salary of the appointee shall not be drawn and disbursed to him till genuineness of his character and antecedents are received from CID and other agencies.
5. If on verification, character and antecedents of the appointee is found adverse or the certificates produced by the appointee are proved fake or forged, his appointment shall be deemed to have been cancelled ab-initio without any further notice.
6. A time of 21 days may be given to the appointee for joining and should be mentioned in the order itself that in case he/she fails to join within this period, his/her appointment shall be deemed to have been cancelled ab-initio without an further notice.
7. The orders issued are without prejudice to the outcome of any petition pending in any competent court of law.
8. Verification of the recognition status/ genuineness of qualification/ category certificates/ permanent resident certificate/ domicile resident of concerned district for a period not less than 15 years except schedule caste category shall be made confidentially by the indenting department from the concerned Universities/ Institutions/ Departments and in case any certificate/ document during the course of verification turns out to be fake/ fictitious, the Department may kindly be kept posted with such outcome so that criminal proceedings against such candidates are initiated.
