Verification of the recognition status/ genuineness of qualification/ category certificates/ permanent resident certificate/ domicile resident of concerned district for a period not less than 15 years except schedule caste category shall be made confidentially by the indenting department from the concerned Universities/ Institutions/ Departments and in case any certificate/ document during the course of verification turns out to be fake/ fictitious, the Department may kindly be kept posted with such outcome so that criminal proceedings against such candidates are initiated.
