Whereas Administrative Department vide their letter No:- HD/FW/70/2017 Dated:-12.01.2017 has forwarded copies of letter No's:- SSB/Sel/Secy/2017/11893-99 Dated: 20.11.2017, received from Services Selection Board Srinagar where under the recommendations in favour of 09, candidates for the post of Female MPHW's District cadre Baramulla has been released.

Whereas the concerned selectees have tendered an undertakings duly attested by the Judicial Magistrate 1st Class to the effect that the requisite certificates submitted by them are genuine & in case any adverse report is received from concerned verifying agencies his/her appointment shall be deemed to have been cancelled ab-initio.

Now therefore pending verification of their testimonials from concerned verifying agencies the below candidates are hereby appointed on regular/temporary basis as Female MPHW's in District cadre Baramulla in the pay band of Rs.5200- 20200 with Grade pay 1900/- strictly in accordance to SRO:- 202 Dated: 30.06.2015, against the available vacant posts of the Health Institutions

Their appointment shall be subject to the following terms & conditions as laid down under SRO:- 202 Dated:- 30.06.2015:-

- 1. A person appointed under these rules shall be initially on probation for a period of five years.
- 2. The appointee shall have necessarily work for a period of five years on the post against which he/she has been appointed & such appointee shall not be eligible for transfer for whatsoever reason during the temporary service of five years. Provided that any person appointed against any available vacancy on the basis of being resident of backward area or an area adjoining line of actual control shall serve in such areas for a period of not less than seven years.
- 3. During the period of first five years, the appointee shall be entitled to the minimum of scale of pay alongwith grade pay only applicable to the post against which he/she is appointed.
- 4. Every appointee shall after completion of five years period on probation be entitled to fixation of pay in the time scale of pay applicable to the post against which he/she is appointed.
- 5. He/She shall be entitled to annual increments, Dearness allowances, HRA & CCA after successful completion of his five years service on consolidated salary.
- 6. He/She shall be entitled to the benefits under the Medical attendance rules & leave rules from the date of his 1st appointment itself.
- 7. The seniority of the person appointed under these rules shall reckon from the date of his appointment.
- 8. The period spent on probation/consolidated salary shall also reckon for purpose of calculating the qualifying service of these appointees for pensioner & other benefits provided under rules.

Further the appointment is also subject to the following conditions:-

- 1. The arrangement if any, made against the post will be simultaneously withdrawn & appointee adjusted.
- 2. The appointment is District cadre & is non-transferable from one District to another District.
- 3. The appointee shall be on probation for a period of five years which shall have to be completed satisfactorily.
- 4. The salary of the appointee shall not be drawn & disbursed to him till geniuness of his character & antecedents report including report from

- other verifying agencies is received by this Directorate & forwarded to the concerned DDO.
- 5. If on verification character & antecedents of the appointee is found adverse or the certificates produced by the appointee are proved take or forged his/her appointment shall be deemed to have been cancelled abinitio without any further notice.
 - 6. These appointees shall report Chief Medical Officer Baramulla within a period of 21, days from the date of issuance of this order & in case he fails to join within this period his appointment shall be deemed to have been cancelled ab-initio without any further notice.

7. The order is without prejudice to the outcome an any petition pending in any competent court of law.
