Now therefore, pending verification of testimonials from concerned verifying agencies Yasmeena Zahoor D/o Mohammad Zahoor Khan R/o Asham Songwari Bandipora is hereby appointed on regular/temporary basis as Female MPHW's in District cadre Bandipora in the pay band of Rs.5200- 20200 with Grade pay 1900/- (Pre-revised) against an available vacancy in District Bandipora strictly in accordance to SRO:- 202 Dated:- 30.06.2015.

The concerned selectee has tendered an undertakings duly attested by the Judicial Magistrate 1st Class to the effect that the requisite certificates submitted by her is genuine & in case any adverse report is received from concerned verifying agencies her appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be allowed to join only on production of the following certificates (in original) to be verified subsequently:-

05. Academic/Technical Qualification Certificate.

06. Matriculation/ Date of Birth Certificate.

07. Health certificate from concerned Chief Medical Officer of the District

08. Permanent Resident certificate issued by competent authority.

Her appointment shall be subject to the following terms & conditions as laid down under SRO:- 202 Dated:- 30.06.2015:-

1. A person appointed under these rules shall be initially on probation for a period of five years.

2. The appointee shall have necessarily to work for a period of five years on the post against which he/she has been appointed & such appointee shall not be eligible for transfer for whatsoever reason during the temporary service of five years. Provided that any person appointed against any available vacancy on the basis of being resident of backward area or an area adjoining line of actual control shall serve in such areas for a period of not less than seven years.

3. During the period of first five years, the appointee shall be entitled to the minimum of scale of pay alongwith grade pay only applicable to

the post against which he/she is appointed.

Every appointee shall after completion of five years period on probation be entitled to fixation of pay in the time scale of pay applicable to the post against which he/she is appointed.

5. She shall be entitled to annual increments , Dearness allowances, HRA & CCA after successful completion of his five years service on consolidated salary.

6. He shall be entitled to the benefits under the Medical attendance rules & leave rules from the date of his 1st appointment itself.

7. The seniority of the person appointed under these rules shall reckon from the date of his appointment.

8. The period spent on probation/consolidated salary shall also reckon for purpose of calculating the qualifying service of these appointees for pensioner & other benefits provided under rules.
