Whereas, the said candidate has submitted his requisite original certificates alongwith affidavit duly attested by Judicial Magistrate, Ist Class, Chadora Budgam to the effect that he shall be liable for termination of his appointment in case any thing adverse is reported against him from any of the verifying agencies including character/ antecedents from CID, J&K.
