Whereas, the Administrative Department Health and Medical Education J&K, Jammu vide their office letter No. HD/NG/380/2015 Dated:-03.2.2016 followed by letter No.HD/NG/380/2015 Dated:-15.03.2016 while forwarding the selection list/recommendations of Jr. Pharmacists (Health Department) District Cadre Jammu, Kathua, Udhampur, Ganderbal, Srinagar, Baramulla, Anantnag, Budgam, Pulwama and Kupwara received through Secretary J&K Services Selection Board Jammu vide letter No's SSB/Secy/Sel/2015/13582-88 Dated: 30.11.2015, SSB/Sel/Secy/2016/110-12 Dated:-02.01.2016, SSB/Sel/Secy/1066-68 Dated:-21.01.2016, SSB/Sel/Secy/2016/1385-87 Dated:-25.01.2016, SSB/Sel/Secy/2015/16442-44 Dated:- 18.12.2015 SSB/Sel/Secy/2015/541-43 Dated:-08.01.2016, SSB/Sel/Secy/2015/538-40 Dated:-08.01.2016, SSB/Sel/Secy/2016/1389-91 Dated:-25.01.2016 and SSB/Sel/Secy/2016/1026-28 Dated:- 20.01.2016 desired to issue formal appointment orders in favour of selected candidates for the post of Junior Pharmacists against various District Cadre posts, subject to the conditions as laid down in the above referred communication of Administrative Department dated:-03.02.2016.

Whereas, after fulfillment of procedural formalities, formal appointment orders were passed / issued in favour of selected candidates in each District, whose candidature was formally recommended by the J&K SSB under different orders.

Whereas, one candidate namely Khursheed Ahmad Hajam S/O:-Faqeer Ah. Hajam R/O:-Salamabad Dachina Boniyar Baramulla who was not earlier selected in the basic selection list of Jr. Pharmacists in District Cadre Baramulla in pursuance of advertisement notification No.07 of 2013 Dated:-16.05.2013 under Item No.639 which got effected by virtue of the cancellation of candidates possessing B.Pharmacy qualification and consequently was assigned revised position in the second selected list in the revised merit position and was allotted fresh merit position as selected candidate at S.No 01 in the RBA merit category with the recommendation being kept withheld by the recruitment Agency (Service Selection Board Srinagar) in terms of Order No.1320-SSB of 2016 Dated:-08.09.2016 for want of clarification with regard to date of completion of 10+2 Diploma.

Whereas, the recruitment agency (SSB Srinagar) finally released the recommendation of the aforesaid candidate vide communication No. SSB/Sel/Secy/140/15/7532-34 Dated:-26.08.2017.

Whereas, Administrative Department vide Communiqué No.HD/NG/380/2015 Dated:-04.04.2018 while forwarding a copy of Order No.1320-SSB of 2016 Dated:-08.09.2016



and communication No.SSB/Sel/Secy/140/15/7532-34 Dated:-26.08.2017 of J&K Service Selection Board regarding the revalidation of selection list for the post of "Jr. Pharmacist" H&ME Department District Cadre Baramulla pursuant to notification No.07 of 2013 under Item No.639 requested to take further action in the matter under SRO-60 Dated:-02.02.2018 which reads as follows:-

(I) In rule, 14, after sub-rule (5) the following shall be added as proviso:-

"Provided that the validity period of one year of the select list of those selectees whose recommendation/selection is kept withheld by the recruiting agency shall be reckoned from the date of release of their recommendation."

(II) After sub-rule (7), the following shall be added as a proviso:-


"Provided that the validity period of one year of the waiting list of those selectees whose recommendations/selection list is kept withheld by the recruiting agency shall be reckoned from the date of release of their recommendation"

Now, therefore, in pursuance of the recommendations made by the J&K Services Selection Board, J&K Jammu/Srinagar and as per the instructions/orders conveyed by the Administrative Department, Health and Medical Education Department under the above referred communications and coupled with SRO-60 Dated:-02.02.2018. Sanction is hereby accorded to the appointment in favour of Khursheed Ahmad Hajam S/O:- Faqeer Ahmad Hajam R/O:- Salamabad Dachina Boniyar Baramulla for the post of "Jr. Pharmacist" in District cadre Baramulla on regular temporary basis in the pay band of Rs.5200-20200 with Grade Pay of Rs.2400(Pre-Revised).The appointment of the appointee shall be governed under the provisions of SRO-400 Dated:-24.12.2009 and the appointee shall report to the Office of Chief Medical Officer Baramulla for his postings in the said District.

The appointment of the above named candidate is subject to following conditions as laid down in the Administrative Department, H & ME letter Dated: 03.02.2016.

1. The arrangements, if any, made against the said post will be simultaneously withdrawn and appointee adjusted.
2. The appointment in District/Divisional cadre is non-transferable from one District/Divisional cadre to another District/Divisional cadre.
3. The appointee shall be on probation for a period of two years.
4. The salary of the appointee shall not be drawn and disbursed to him till genuineness of his character and antecedents are received from CID and other agencies.
5. If on verification, character and antecedents of the appointee are found adverse or the certificates produced by the appointee are proved fake or forged, his appointment shall be deemed to have been cancelled ab-initio without any further notice.
6. The appointee shall join his duties within 21 days from the date of issuance of this order failing his appointment shall be deemed to have been cancelled ab-initio without any further notice.
7. The order issued is without prejudice to the outcome of any petition pending in any competent court of law.
