Whereas, the Administrative Department Health and Medical Education J&K, Jammu & Srinagar vide their office letter No. HD/NG/86/2017 Dated:-21.04.2017 followed by letter No.HD/NG/86/2017 Dated:-08.06.2017 & HD/NG/86/2017 Dated:-20.07.2017 while forwarding the selection list/recommendations of "Health and Family Welfare Assistant" (Health and Medical Education Department) District Cadre Kupwara received through Secretary J&K Services Selection Board Jammu/Srinagar vide letter No. SSB/Secy/Sel/2017/1656-61 Dated: 03.02.2017, desired/requested to issue formal appointment orders in favour of selected candidates for the post of Health and Family Welfare Assistant District Cadre Kupwara on the terms and conditions as laid down in the above referred communication of Administrative Department dated:-21.04.2017.

Whereas, after fulfillment of procedural formalities, formal appointment orders were passed / issued in favour of selected candidates in District Cadre Kupwara whose candidature was formally recommended by the J&K Service Selection Board in terms of this Office Order No.312/NG of 2017 Dated:-03.08.2017.

Whereas, the recommendations of candidates figuring in the selection list at S.No 03, 06, 07 & 09 under OM Category and S.No.03 under RBA Category was kept withheld by the recruitment Agency (Service Selection Board, Jammu) for want of clarification on various grounds.

Whereas, the recruitment agency (Service Selection Board Srinagar) finally released the recommendations of the candidates figuring in the selection list at S.No.03, 06, 07 & 09 under OM Category and S.No.03 under RBA category in terms of communication No.SSB/Sel/Secy/51/17/5466-68 Dated:-12.06.2017 which was received in this office in terms of letter No.HD/NG/86/2017 Dated:-20.07.2017 of the Administrative Department H&ME J&K Srinagar.

Whereas, after fulfillment of procedural formalities, formal appointment orders were passed/issued in favour of selected candidates to the post of "Health and Family Welfare Assistant in District Cadre Kupwara" whose candidature was initially withheld by the Recruitment Agency Service Selection Board (SSB) and later on released in terms of this Office Order No.348/NG of 2017 Dated:-19.08.2017.

Whereas, Chief Medical Officer Kupwara in terms of Communiqué No.CMOK/Estt/3637 Dated:-12.09.2017 intimated/apprised this Directorate that in pursuance of Formal Appointment Order Issued by this office in terms of No.348/NG of 2017 Dated:-19.08.2017, one of the selected candidate namely Sajad Ahmad Mir S/O:-Abdul Aziz Mir R/O:-Ashipora Tehsil Handwara District Kupwara neither joined at CMO Office Kupwara nor at proposed place of posting viz S/S Kuchban Jumgand Block Trehgam within stipulated period of time.

Whereas, consequently Sajad Ahmad Mir S/O:-Abdul Aziz Mir R/O:-Ashipora Tehsil Handwara District Kupwara figuring at S.No.06 in the selection list under OM Category of Health and Family Welfare Assistant District Cadre Kupwara and in whose favour appointment order was issued by this Directorate in terms of Order Dated:-19.08.2017 furnished undertaking/affidavit in this office duly attested by Executive Magistrate Ist Class Srinagar wherein stating that he is neither interested nor want to join the post of "Health and Family Assistant" District Cadre Kupwara and solicit this affidavit/undertaking before the authorities and the contents therein are based on facts and if found fake he shall be personally/legally responsible for the consequences/ramifications.

Whereas, this Directorate acting in accordance issued Cancellation Order that was published in leading Newspaper of the valley viz Greater Kashmir in its edition dated:-09.10.2017 in respect of Sajad Ahmad Mir S/O:-Abdul Aziz Mir R/O:-Ashipora Tehsil Handwara District Kupwara in terms of this office No.Est-II/NG/Sel/H&FW Asst/1787-92 Dated:-07.10.2017 wherein his appointment to the post of "Health and Family Welfare Assistant District Cadre Kupwara" was cancelled abinitio.

Whereas, this Directorate accordingly communicated with Administrative Department H&ME in terms of letter No.EST-II/NG/H&FW Asst/Recom/2029 Dated:-18.10.2017 therein apprised about the whole facts of the case and subsequently requested to authorize this Directorate to operate waiting/list in respect of one incumbent namely Mohd. Akther Bhat S/O:-Gh. Mohd Bhat R/O:-Lalpora, Kupwara figuring in the waiting list at S.No.01 under OM category of "Health and Family Welfare Assistant District Cadre Kupwara" in the basic selection list for the said district.

Whereas, in response Administrative Department H&ME in terms of communication No.HD/NG/86/2017 dated:-04.12.2017 conveyed approval of the Administrative Department for operating the waiting list, in terms of Sub-rule(7) of Rule 14 of Civil Services Decentralization and Recruitment Rules, 2010.

Whereas, the incumbent falling at S.No.01 of Waiting list of Health and Family Welfare Assistant District Cadre Kupwara viz Mohd. Akther Bhat S/O:- Gh. Mohd Bhat R/O:- Lalpora Kupwara has tendered affidavit/undertaking duly attested by Executive Magistrate Ist Class Srinagar to the effect in case the requisite documents/certificates submitted by him and character antecedents on verification are proved fake/forged or concealed adverse respectively, he shall be personally liable for action as warranted under rules and his appointment shall be terminated abinitio without any notice.

Now, therefore in pursuance of the recommendations made by the J&K Services Selection Board, J&K Jammu/Srinagar and as per the approval conveyed by the Administrative Department H&ME Department under the above referred communications, Sanction is hereby accorded to the appointment of Mohd. Akther Bhat S/O:- Gh. Mohd Bhat R/O:- Lalpora Kupwara for the post of "Health and Family Wlefare Assistant" District Cadre Kupwara on regular temporary basis in the pay band of Rs.5200-20200 with Grade Pay of Rs.2400 subject to the pending verification of his documents/CID reports from concerned quarters. The appointment of the appointee shall be governed under the provisions of SRO-



400 Dated;-24.12.2009 and shall report to the Office of Chief Medical Officer Kupwara for his posting in the said District.

The appointment of the above named candidates is subject to following conditions as laid down in the Administrative Department, H & ME letter Dated: 21.04.2017.

- 1. The arrangements, if any, made against the said post will be simultaneously withdrawn and appointee adjusted.
- 2. The appointment in District/Divisional cadre is non-transferable from one District/Divisional cadre to another District/Divisional cadre.
- 3. The appointees shall be on probation for a period of two years.
- 4. The salary of the appointee shall not be drawn and disbursed to him till genuineness of his character and antecedents is received from CID and other agencies.
- 5. If on verification, character and antecedents of the appointee is found adverse or the certificates produced by the appointees are proved fake or forged, his appointment shall be deemed to have been cancelled ab-initio without any further notice.
- 6. The appointees shall join his duties within 21 days from the date of issuance of this order failing his appointment shall be deemed to have been cancelled ab-initio without any further notice.
- 7. The order issued is without prejudice to the outcome of any petition pending in any competent court of law.
- 8. The recognition status/genuineness of qualification/category certificates/permanent resident certificate/Domicile Resident of concerned district for a period not less than 15 years except SC Category shall have to be verified the indenting department confidentially from the concerned universities/institutions/departments and in case any certificate/document during the course of verification turns out to be fake/fictitious, the Administrative department may kindly be kept posted with such outcome, so that criminal proceedings against such candidates as initiated:
