Government Order No. 310-HME of 2013

D a t e d. 25-04-2013.

Whereas, a list of 90 unauthorized absent doctors was furnished by Director Health Services, Kashmir to the Administrative Department vide letter No Est/31-133/3091 dated 30-11-2012, and

Whereas, vide No. HME/HRM/55/2011 dated 10-10-2012 a notice was served through leading daily newspaper to all 90 doctors whereunder they were asked to report back to the Directorate of Health Services, Kashmir failing which action under rules shall be initiated against them; and

Whereas, in response to the Notice, Director Health Services, Jammu vide letter No Est/31-133/3091 dated 30-11-2012 has intimated the factual position of the cases and accordingly their cases have been examined in the department, and

Whereas, 38 doctors have not reported to the Directorate of Health Services, Kashmir after issuance of Final Notice and have failed to avail opportunity given by the department for explaining the reasons for their unauthorized absence, thereby clearly indicating their non interest in joining back and rendering the services to the department; and

Now, therefore the services of the below listed doctors are hereby terminated:


