The selection has been made on the basis of the merit obtained by individual candidates in the written / screening test (available on the official website of GMC Srinagar viz gmcs.edu.in) as had been notified vide No. DHSK/Schemes/ATF/ 2021-222/1715-28 dated 30/07/2021. However, preference has been given to the candidates with higher academic merits in case where two or more candidates were having same points in the screening test. Moreover, minimum 50% marks in the written test have been considered mandatory for qualifying the test.

Besides, preference has been given to the candidates belonging to the corresponding Districts as per the Advertisement Notice. In addition, candidates from outside the local district were considered only wherever no eligible candidate had qualified.

#### Terms & conditions:

1. The engagement is provisional and subject to the receipt of satisfactory report of verification of all requisite academic / qualification / marks certificates / Domicile certificate & other relevant documents.
2. The selected candidates shall have to join in the office of the Medical Superintendent of concerned District Hospital (ATFs) as mentioned against each within a period of seven (07) days from the date of publication of this notification, failing which the engagement shall be deemed to have been cancelled without any further notice and the waiting list will be operated.
3. The selected candidates shall have to produce original as well as photostat copies of all requisite academic / qualification / marks certificates / Domicile Certificate of concerned district & other relevant documents at the time of joining.
4. The selected candidates shall be paid consolidated monthly honorarium as mentioned in the advertisement notice.
5. In case the selected candidate wants to leave the job, he / she shall have to give one month's prior notice to the concerned Medical Superintendent.
6. Initial term of the engagement is one year from the date of appointment, extendable on yearly basis subject to good performance of the candidate or till the continuation of the scheme, whichever is earlier.
7. The selected candidates shall have to submit an affidavit / undertaking duly signed by 1<sup>st</sup> Class Magistrate that he / she shall not claim for any permanent absorption / transfer.

8. If the contractual appointee, at any point of time wilfully neglects or refuses to perform his / her duties, his contractual appointment shall be immediately terminated without any notice and he / she shall not be entitled to any honorarium for such period.
9. In case of poor performance, the engagement of the candidate shall be liable to be terminated without any notice.
10. The engagement is also subject to the outcome of any writ petition(s) in any Court of competent jurisdiction.
