Whereas, this office had received SRO-43 case of Fiza FAROOQ D/O Deceased Farooq Ahmad Mir Ex Chauffer of Associate Hospital GMC Baramulla R/O Kaker Hamam District Baramulla ,who died in harness on 10.09.2020, as per death certificate issued by Registrar Births and Deaths M.C Baramulla Kashmir vide their office NO:-MC/Bla/D&B/272 DT:-05.10.2020.

Whereas, this office had forwarded her SRO-43 Case to Administrative Department for necessary relaxation in lower age limit vide this office letter no:-DHSK/Est-4/NG-478/SRO-43/2104 DT:-25.05.2021.

Whereas, the Administrative Department vide their office letter NO:-HD-NG-K/30/2021-02 DT:-27.07.2021,had asked to this office to clarify as to how the deceased employee was granted promotions and subsequent benefits by the Directorate as he was borne on the establishment of Director Garages.

Whereas, this office vide letter NO:-DHSK/Est-4th/NG-478/3931 Dt:-20.10.2021 had informed that the deceased was initially appointed as cleaner on the temporary basis Director Garages, I/C SHTO Srinagar vide order NO:-EST/SHTO/S/42-43 DT:-12.04.1984 and in the year of 2002 the administrative control of SHTO was transferred from Director State Motor Garages Jammu and Kashmir to the Director Health services Kashmir/Jammu vide Govt Order NO:-385-HME of 2003 DT:-21.04.2003,further it is also mentioned in the said Govt Order that the Dy.Director Health Services(HQ) shall be drawing and Disbursing officer and Supervisory officer in place of Deputy Director Garages Jammu and Srinagar respectively, Since then the SHTO Srinagar is working under the Administrative Control of this Directorate.

Whereas, the Administrative Department vide their office letter NO:-HD-NG-K/30/2021-02 DT:-22.12.2021, read with letter No. letter No.HD-NG-K/30/2021-02 (CC.NO.35264) dated. 07.11.2023 had advised this office to settle the Compassionate Appointment case of Mst. Fiza Farooq D/O Deceased late Farooq Ahmad Mir,Ex.Chauufer (Driver) R/O Kaker Hamam District Baramulla at the level of this Directorate against the post of Class-IVTH under SRO-43 of

1994, as amended from to time, after the applicant attains the age of 18 yerars and after reckoning her age with reference to Ist January of the year in which she is being considered for appointment, as no relaxation is involved in the case.

Whereas, this office vide letter no:-DHSK/EST-4TH/NG-478/Ver/224 DT:-11.01.2022 had sent the Character and antecedents of the Candidate in question to the Addl Director General of Police CID J&K Government Kashmir/Jammu in terms of Govt Order No;-528-JK(GAD) of 2021 DT:-21.06.2021 for its verification.

Whereas, the Spl.Director General CID J&K Jammu has furnished their report vide their office Communication NO:-CID/MR/SRO-43/2022/64 DT:-07.03.2022, that Ground verification conducted reveal that nothing adverse has been reported against the individual as well as her deceased father. The father of the individual was working in Health Department, who died due to cardiac arrest on 10.09.2020

Now, therefore, in view of details given herein above and pending verification of her testimonials/ documents from concerned verifying agencies, Sanction is hereby accorded to the appointment of Fiza Farooq D/O Late Farooq Ahmad Mir (deceased Chauffer) R/o Kaker Hamam, Chinad Khushalpora District Baramulla as MTS (Orderly)" on regular temporary basis on Compassionate grounds in terms of SRO-43 of 1994, amended with/read with S.O.429 dt:-06.09.2022 against the post caused vacant at PHC Warikah Block Boniyar in the Revised Pay Level SL1 of Rs. (14800-47100) plus usual allowances as admissible under rules with immediate effect. The case is strictly covered under NPS SRO-400 dated: 24-12-2009.

The Appointee shall report to the Chief Medical officer Baramulla within a period of twenty one days (21) days from the date of issuance of this order and shall be allowed to join only on production of the following documents /certificates.

 - That he/she will give an undertaking in the shape of an affidavit dully a. attested by the Judicial Magistrate Ist class to the effect that if on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as MTS (Attendant)(Class-IVth) to have been cancelled ab-intio and the legal action as warranted under rules shall be initiated against the applicant.

- The salary of the appointee shall not be drawn and disbursed to him unlesssatisfactory report in respect of (a) above is received in her
- The appointment of the candidate shall be governed by the New C. pensionScheme as per SRO-400 of 2009 DT:-24.12.2009.
- If the appointee fails to join within a period of 21 days from the date of d. issuance of this order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-inition without any further

This order is however, subject to outcome of writ petition (s) of any pending in any Competent Court of law
