Subject:- Compassionate appointment case of Mr. Danish Ahmad Mochi S/O Late Abdul Rahim Mochi R/o Donipawa, District Anantnag under SRO-43 of 1994

Whereas, this office has received the Compassionate appointment case of Mr. Danish Ahmad Mochi S/O Late Abdul Rahim Mochi, deceased Safaiwalla R/O Donipawa, District Anantnag from Chief Medical Officer, Anantnag, vide communication No. Est-2nd/Compt/Apptt./SRO-43/1606-07 dated 31-05-2021 consideration of his appointment under SRO 43 of 1994.

Whereas, as per the reports received from Chief Medical officer, Anantnag deceased Abdul Rahim Mochi was working as Safaiwalla on regular establishment who died in harness on 06-03-2021 as per the death certificate issued by the Registrar Birth & Death Department Anantnag vide his registration No. 97 dated 10-04-2021.

Whereas, as per the dependent certificate issued by the Assistant Commissioner, Anantnag vide his No. 39/LH/Dep/SRO-43 dated 19-05-2021 the deceased has left behind the following dependents.



Whereas, the dependent No.1,3,4, have tendered joint affidavit dully attested by the Judicial Magistrate Ist Class Anantnag to the effect that they have no objection if dependent NO 2 namely Mr. Danish Ahmad Mochi S/O Late Abdul Rahim Mochi, deceased Safaiwalla R/O Donipawa, District Anantnag is appointed in terms of SRO 43 of 1994 on compassionate grounds.

Whereas, dependent No. 02 has also tendered a separate affidavit dully attested by the judicial magistrate Anantnag to the effect that he will look after the other dependents of the deceased on availing the benefits of appointment.

Whereas, the Administrative Department vide letter No.HD-NG-K/89/2021-02 (CC No.90361) dated 20-11-2023 has authorized this office to issue formal appointment order in favour of the applicant namely Mr. Danish Ahmad Mochi S/O Late Abdul Rahim Mochi, ex- Safaiwalla R/O Donipawa, Tehsil and District Anantnag figuring at S.No. 4 in Administrative Department against the post of Sanitation worker after fulfillment of codal formalities as prescribed in SRO-43 of 1994 which includes character and antecedents verification report also

Now therefore in view of the above, sanction is hereby accorded to the appointment of Mr. Danish Ahmad Mochi S/O Late Abdul Rahim Mochi, deceased Safaiwalla R/O Donipawa, District Anantnag and is adjusted against the available post of Sanitation worker at Chief Medical Officer, Anantnag on regular/temporary basis on compassionate grounds in terms of SRO 43 of 1994 in the pay level of SL1 (14800-47100) plus other usual allowances admissible under rules.









The applicant shall join in the Office of Chief Medical Officer, Anantnag within a period of 21 days from the date of issuance of this order subject to the following condition and on the production of following required certificates before the concerned Chief Medical Officer, Anantnag.

1. Academic qualification certificate.
2. Date of birth certificate.
3. Domicile certificate.
4. Health certificate form the concerned CMO of the District.
5. Dependent certificate issued by the Assistant commissioner Revenue.
6. Non-loanee certificate under self Employment scheme from DIC concerned and employment Department.
7. All other relevant documents as are required under SRO 43 /1994.

The appointment of the appointee shall further be subject to the following condition:

- a. That he/she will give an undertaking in the shape of an affidavit dully attested by the judicial Magistrate Ist class to the effect that if on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Sanitation worker to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against the applicant.
- b. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of (a) above is received in his favour.
- c. The appointment of the candidate shall be governed by the new pension scheme as per SRO 400 of 2009 dated 24.12.2009.
- d. If the appointment fails to join within a period of 21 days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

This order is however, subject to outcome of writ petition(s) of any pending in any competent court of law.

- 1)- The Chief Medical Officer, Anantnag Shall not draw the salaries until and unless the verification report with regard to character/antecedents is received from concerned agencies.
- 2)- The appointee shall be on probation for period of (02) years which he has to complete satisfactorily.
- 3)- That the appointee will look after the family left behind by the (deceased at Chief Medical Officer, Anantnag) as per affidavit submitted by him. In case any thing adverse is reported and proved the appointment shall b e treated as cancelled.


