Subject:-Compassionate appointment case under SRO-43 in favour of Ifhamul Haq S/O late Bashir Ahmad Matta (Ex. Sr. Theatre Tech).

Whereas, Chief Medical Officer Baramulla vide endst. No: Est/CMO/Bla/3907 dated 08.08.2022 has forwarded the compassionate appointment case of Ifhamul Haq S/O late Bashir Ahmad Matta (Ex. Sr. Theatre Tech) R/O kartargah Tehsil Watergam (Alsafa Colony Sopore), District Baramulla for consideration of his appointment under SRO-43 of 1994.

Whereas, as per the service records the deceased was initially appointed as Medical Assistant on the recommendation of Chairman J&K State Subordinate Recruitment Board Srinagar /Jammu & Directorate of Health Services Kashmir order No:Est-MA/15355 -403 dated 18.11.1988 & has died during active service on 25.05.2022 as per the death certificate issued by Registrar Births and Deaths SHO P/S Sopore vide registration No:147/15-B/Sopore/2022 Dated: 28-05-2022.

Whereas, as per the dependent certificate issued by office of the Additional Deputy Commissioner Sopore vide No:ADC/Spr/Dep/22/14-15 dated 20.07.2022 deceased employee has left behind the following dependents: -

Whereas, the dependent No: (02) Ifhamul Haq son of deceased employee has submitted an affidavit/ undertaking duly attested by Hon'ble Munsiff / District Mobile Magistrate Traffic Baramulla /Kupwara/ Bandipore to the effect that he will look after the other dependents of deceased employee on availing the benefit of compassionate appointment under SRO-43 of 1994 in the Department.

Whereas, the dependent No: (01, 03 & 04) Mehbooba Bashir spouse of deceased employee, Zariya Bashir daughter of deceased employee and Aisha Begum mother of deceased employee have submitted an affidavit/ undertaking duly attested by Hon'ble Munsiff / District Mobile Magistrate Traffic Baramulla /Kupwara/ Bandipore that they have no objection if dependent No: 02 namely Ifhamul Haq son of Deceased Bashir Ahmad Matta (Sr. Theatre Tech) is appointed in terms of SRO-43 of 1994 on compassionate grounds.

Whereas, Criminal Investigation Department (CID) Govt. of Jammu & Kashmir has also furnished report wherein it has been stated that ground verifications conducted reveals that nothing adverse has been reported against Ifhamul Haq S/O Late Bashir Ahmad Matta R/O kartargah Tehsil Watergam (Alsafa Colony Sopore), District Baramulla under their communication No: 25994 dated 20.10.2022.

Whereas, in response to this office letter No: EST-II/P.F./SRO43/76/6134 dated 06.10.2022, the J&K State Board of School Education new campus Bemina has furnished genuineness report of Matriculation / Date of Birth Certificate vide their No:F(JS-Ver)/B/KD/2022/F-5754 dated 18.10.2022

Whereas, in response to this office letter No:Est-II/SRO-43/76/6936 dated 01.11.2022, Tehsildar Watergam vide letter No:T-Wtg/JC/2022-23/408 dated 12.11.2022 has furnished genuineness report with regard to Domicile Certificate in favour of Ifhamul Haq S/O Late Bashir Ahmad Matta.


Whereas, a copy of O.M. No. GAD –SRO/91/2023 (7315589) Dt:- 30.10.2023 received from GAD by the Administrative Department regarding the above captioned subject ,authorized this office to issue formal appointment order in favour of the Applicant namely Ifhamul Haq S/O late Bashir Ahmad Matta (Ex. Sr. Theatre Tech) R/O kartargah Tehsil Watergam (Alsafa Colony Sopore), District Baramulla against the available vacancy of class ivth (MTS) in District Baramulla after fulfillment of all codal formalities as prescribed in the SRO 43 of 1994 as well as reflected in the communication under reference, which includes Character and antecedents verification report also .

Now, therefore, in view of details given herein above and verification of his testimonials/ documents from concerned verifying agencies, Sanction is hereby accorded to the appointment of Ifhamul Haq S/O late Bashir Ahmad Matta (Ex. Sr. Theatre Tech) R/O kartargah Tehsil Watergam (Alsafa Colony Sopore), District Baramulla as MTS (class IVth) on regular temporary basis on compassionate grounds in terms of SRO-43 of 1994, against the available vacancy at Trauma Hospital Watergam Rafiabad Block Dangiwach District Baramulla in the Revised Pay Level SL1 of Rs. (14800-47100) plus usual allowances as admissible under rules. The case is strictly covered under SRO-400 dated: 24-12-2009 (New Pension Scheme).

The applicant shall join in the office of Chief Medical Officer, Baramulla within a period of (21) day from the date of issuance of this order subject to the following terms & conditions, failing which his appointment shall be deemed as cancelled without any notice.

Terms & conditions.

1. That the appointee shall be on probation for a period of (02 years), which shall have to be completed satisfactory.
2. The concerned drawing and disbursing officer shall not draw the salary of the concerned official until & unless fulfilling of all codal formalities including



acceptance of genuineness reports of his documents from concerned verifying agencies.

3. It shall be the binding / obligatory on the appointee to serve the bereaved family with the income to be derived from the said employment for which an undertaking shall also be obtained from the appointee duly attested by 1st Class Magistrate.
4. Any confirmed deviation from the agreement shall result in the forfeiture of the job for which the appointing authority (Director Health Services Kashmir shall on receipt of such complaint have the authority to initiate action and the appointee in such case shall be left with no right to agitate the matter before any forum whatsoever, after decision taken by the appointing authority.

However genuineness report of the following certificates of Ifhamul Haq included character and antecedent report has been received by this Directorate from the concerned agencies.

- Matriculation / Date of Birth Certificate
- Domicile Certificate
- Character and antecedent from Criminal Investigation Department.
