Whereas, this office has received the Compassionate appointment case of Shri Mohammad Shoib S/O Noor Mohammad Kawa deceased Dhobi R/O illahi Bagh Srinagar from Medical Superintendent JLNM Hospital, Raniwari Srinagar, vide communication No. JLNM/2021-22/1337 dated 28-2-2022 for consideration of his appointment under SRO 43 of 1994.

Whereas, as per the reports received from Medical Superintendent, JLNM Hospital Raniwari Srinagar deceased Noor Mohammad was working as Dhobi on regular establishment who died in harness on 15-11-2021 as per the death certificate issued by the Registrar Birth & Death Srinagar Municipal Corporation vide his registration No. 11954 dated 07-12-2021.

Whereas, as per the dependent certificate issued by the Assistant Commissioner, Srinagar vide his No. DCS/SM/455/9763 dated 16-2-2022, the deceased has left behind the following dependents.

Releationship with the deceased Name of the dependents S.No. Shaheena Wife 1. 2. | Shoiab Son Daughter 3. | Sehrish

Whereas, the dependent No.1 and 3 have tendered an affidavit dully attested by the Judicial Magistrate Ist Class Srinagar to the effect that they have no objection if dependent NO 2 namely Shoib S/O Noor Mohammad Kawa deceased Dhobi R/O Illahi Bagh Srinagar is appointed in terms of SRO 43 of 1994 on compassionate grounds.

Whereas, dependent No. 02 has also tendered a separate affidavit dully attested by the judicial magistrate Srinagar to the effect that he will look after the other dependents of the deceased on availing the benefits of appointment.

Whereas, the Administrative Department vide letter No.HD-NG-K/32/2023-02 (CC No.7140870) dated 07-011-2023 has authorized this office to issue formal appointment order in favour of the applicant namely Mr. Mohammad Shoib, S/O Late Noor Mohammad Kawa, Ex-Dhobi, JLNM Hospital, Srinagar figuring at S.No.6 in Administrative Department against the post of Class-IV (MTS) after fulfillment of codal formalities as prescribed in SRO-43 of 1994 which includes character and antecedents verification report also



Now therefore in view of the above, sanction is hereby accorded to the appointment of Mr Mohammad Shoib S/O Noor Mohammad Kawa Deceased Dhobi R/Oillahi Bagh Srinagar and is adjusted against the available post of Class-IV (Multi Tasking Staff) at JLNM Hospital gainawari Srinagar on regular/temporary basis on compassionate grounds in terms of SRO 43 of 1994 in the pay level of SL1 (14800-47100) plus other usual allowances admissible under rules.

The applicant shall join in the Office of Medical Superintendent JLNM Hospital Rainawari Srinagar within a period of 21 days from the date of issuance of this order subject to the following condition and on the production of following required certificates before the concerned Medical Superintendent JLNM Hospital Rainawari Sriangar.

- 1. Academci qualification certificate.
- 2. Date of Birth certificate.
- 3. Domicile certificate.
- 4. Health Certificate from the concerned CMO of the District.
- 5. Dependent certificate issued by the Assistant Commissioner revenue.
- 6. Non-loanee certificate under self-employment scheme from DIC concerned and employment Department.
- 7. All other relevant documents as are required under SRO 43/1994.
- 8. The Meddical Superintendent JLNM Hospital Raniwari Srinagar Shall not draw the salaries of the appointee until and unless the verification report with regard to character/antecedents is received from concerned agencies.
- 9. The appointee shall be on probation for period of (02) years which he has complete satisfactorily.
- 10. That the appointee will look after the family left behind by the (deceased at JLNM Hospital, Srinagar) as per affidavit submitted by him. In case any thing adverse is reported and proved the appointment shall be treated as cancelled.

The appointment of the appointee shall further be subject to the following condition:-

- a. That he /she will give an undertaking in the shape of an affidavit dully attested by the Judicial Magistrate Ist class to the effect that if on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointmentas MTS/(attendant)class-IVth)to have been cancelled ab-intio and the legal action as warranted under rules shall be initiated against the applicant.
- b. The appointment of the candidate shall be governed by the New pension scheme as per SRO -400 of 2009 dated 24-12-2009.
- c. If the appointee fails to join within a period of 21 days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-inition without any further notice.
- d. This order is however, subject to outcome of writ petition (s) of any pending in any competent court of law.
