Whereas, this office has received the Compassionate appointment (SRO43) case of Mtr.Naza W/o Late Noor -ud- Malik (Deceased Jr. Laboratory Technician) R/O Sariwarpora Tehsil Pattan District Baramulla ,who died in harness on 26.12.2021 as per death certificate issued by Registrar Births and Deaths (Police Station Pattan Baramulla) as per the case received from CMO Baramulla letter No.Estt/CMOB/18032-33 dtd. 21.02.2023

Whereas the instant case was submitted to Administrative Department vide this office letter DHSK/Est-4/Ng -54/SRO -43/1900 dated. 16.04.2022 for necessary Relaxation in qualification or instructions in the instant matter on the merits of the case

Whereas the Administrative Department vide their letter No. HD-NG-K/75/2022-02 (CC No. 182782) dated. 15.11.2023 has authorized this office for issuance of formal appointment order in respect of the applicant namely Mtr. Naza Bano W/O Late Noor-ud-Din Malik (deceased Jr. Laboratory Technician ) R/O Sariwarpora Tehsil Pattan District Baramulla figuring at Serial No. 13 of enclosed annexure of O.M No. GAD-SRO/96/2023(7317734) dated. 03.11.2023 against the post of Class-Iv/MTS (Orderly) after fulfillment of all the codal formalities as prescribed in the SRO-43/1994 as well as reflected in the communication under reference which includes character and antecedents verification report .

Now in view of details given herein above and pending verification of her testimonials/ documents from concerned verifying agencies, Sanction is hereby accorded to the appointment of Mtr.Naza W/o Late Noor-ud-Malik (deceased Jr. Laboratory Technician R/O Sariwarpora Tehsil Pattan District Baramulla as class – IV/MTS( Orderly)” on regular temporary basis on Compassionate grounds in terms of SRO-43 of 1994, against the post lying at Block Pattan Tehsil Pattan District Baramulla in the Revised Pay Level SL1 of Rs. (14800-47100) plus usual allowances as admissible under rules with immediate effect.

The Appointee shall report to the Chief Medical officer Baramulla within a period of twenty one days (21) days from the date of issuance of this order and shall be allowed to join only on production of the following documents /certificates in original.

01. Academic qualification certificate
02. Date of birth certificate



03. Domicile certificate
04. Health certificate from the concerned District Medical Board.
05. Dependent certificate issued by the Assistant commissioner revenue
06. Non loanee certificate under self-Employment Scheme from DIC Concerned and Employment Department.
07. All other relevant documents as required under SRO-43 /1994
08. The appointment of the appointee shall further be subject to the following

Condition:-

- a. That he/she will give an undertaking in the shape of an affidavit dully attested by the Judicial Magistrate Ist class to the effect that if on verification, genuineness of the qualification certificates from the concerned issuing authority is found fake/forged, the claim of the appointee for appointment as Class-IV/MTS(Orderly) to have been cancelled ab-intio and the legal action as warranted under rules shall be initiated against the applicant.
- b. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory verification report with regard to character /antecedents is received from concerned agencies in her favour.
- c. The appointment of the candidate shall be governed by the New pension Scheme as per SRO-400 of 2009 DT:-24.12.2009.
- d. The appointee shall be on probation for period of (02) years which she has to complete satisfactorily.
- e. That the appointee will look after the family left behind by the (deceased) against whom her appointment is made and as per the affidavit submitted by her. In case any thing adverse is reported and provided the appointment shall be treated as cancelled
- f. If the appointee fails to join within a period of 21 days from the date of issuance of this order, he shall forego his right to appointment which shall be deemed to have been cancelled ab-inition without any further notice.
- g. This order is however, subject to outcome of writ petition (s) of any Pending in any Competent Court of law.
