- 2. The contractual hiring shall not confer any right on the appointee to claim extension or for regular selection at any point of time.
- 3. The hiring is purely fresh one governed by the Terms and Conditions laid down in the above mentioned notification and all such candidates who were working under NHM, J&K, if appeared in the Walk-in Interview in pursuance to the above stated notification and have been selected, shall have no claim of benefits of their previous period of service under NHM for any purpose, one month remuneration will be forfeited for which he/she shall no claim what so ever.
