Sub:- Conducting of Type Test of Departmental Matriculate Orderlies on Computer Key Board.

N O T I F I C A T I O N

Whereas, the applications were invited from eligible Departmental Orderlies for conducting of Type Test on Computer Key Board appointed by the Competent Authority alongwith their initial appointment orders through the concerned Chief Medical Officers/ Controlling Officers vide this office No: Est-5/NG-61/2657-73 dated: 12-11-2016 .

Whereas, the concerned CMO's were directed to produce certificate to the effect that there is no left out Matriculate Orderly pending in their respective Districts.

Whereas, in response to this office letter No referred to above this office is in receipt the requisite information/documents alongwith first appointment order copies from the concerned Chief Medical Officers/ concerned Controlling Officers and after scrutinized the papers it has been found that Gardner, Ayas, Chowkidar Safaiwalla's have applied for the Type Test as per rules they are not eligible for Type Test.

Whereas, a committee of officers/ officials were constituted to ascertain eligibility of Matriculate Orderlies as per SRO-20 for conducting of Type Test vide this office order No: 35/NG of 2017 dated: 24-01-2017.

Whereas committee has submitted its report and recommended that only 05 orderlies have applied for the Type Test. The maximum number of candidates have been appointed as Nursing Orderlies and Class-IV and the committee recommended that these should be considered for Type Test on the plea that they have same Pay Scale and same job function, and as per caderization in vogue these posts needs to be filled on the basis of District Cadre and in respect of such candidates who have been appointed in Divisional Cadre needs to be filled under Divisional Cadre.

Now, therefore the list of candidates who have applied for the Type Test on Computer Key Board is given below for inviting objections if any in this regard. The objections should reach to this Directorate with 15 days from the date of issuance of this notification alongwith documentary evidence, after expiry of the stipulated time no claim whosoever shall be considered.
