The appointment of aforementioned candidate shall be subject to the following conditions as reflected in the communication of Adm. Department's letter Dated:-20.07.2021:-

1. The arrangement, if any, made against the said post will be simultaneously withdrawn and appointee be adjusted.
2. The appointment in District/Division Cadre is non-transferable from one District/Divisional Cadre to another District/Divisional cadre.
3. The appointee shall be on probation for a period of two (02) years and their probation shall be governed by the Jammu & Kashmir Probation (Condition of Service, Pay and Allowances) and Fixation of Tenure Rules, 2020 notified vide S.O 192 Dated:-17.06.2020.
4. A time of 21 days is given to the above said appointee for joining an in case of failure, within the said period, their

appointment shall be deemed to have been cancelled ab-initio without any further notice.

5. Besides, **the candidate who fails to join within a period of 21 days (twenty one) from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled abinitio without any further notice.** This is in pursuance to the Circular issued by GAD vide No.08-JK (GAD) of 2019 Dated:-04.12.2019.
6. The orders issued are without prejudice to the outcome of any petition(s) pending before any competent court of law.
7. Verification of the recognition status/genuineness of qualification/category certificates/permanent Resident certificate/Domicile Resident of concerned District for a period not less than 15 years except Schedule Case Caste has been made by this Directorate and the reports of the same are awaited from the respective concerned quarters. **The concerned DDO's are requested not to draw and disburse the salary of aforesaid appointee till verification report is not received and forwarded to your offices by this Directorate.**
8. In case any certificate/documents during the course of verification turn out to be fake/fictitious, the department of Adm. Department has to be kept posted with such outcome so that criminal proceeding against such candidate(s) is initiated.
9. **The appointment order shall have its notional effect from 06.10.2021 i.e after the part of selection list has been operated upon in pursuance to the Govt. Order No. 528-JK(GAD) of 2021 Dated:-21.06.2021.**
