SUBJECT:- VISITING THE DIRECTORATE WITHOUT STATION PERMISSION FROM CONCERNED CHIEF MEDICAL OFFICERS BY FIELD STAFF/DOCTORS.

It has been observed that many field officials/staff members from different institutions are frequently visiting the Directorate without taking station permission from the concerned Chief Medical Officers. This is badly affecting the patient care and is also resulting in indiscipline at different levels.

It is hereby ordered that no Doctor, Paramedic or any other employee/staff member of the health services department Kashmir shall leave his/her station to visit the Directorate without written permission from the concerned Chief Medical Officer/Medical Superintendent. Similar permission shall be sought by all the employees while moving from their respective stations under justified reasons.

All the CMO's/BMO's/Medical Superintendents shall keep proper check on the attendance of their employees.

Any default in this regard shall invoke serious disciplinary action against the

erring officials and the concerned Officers.

#### CIRCULAR

It has been observed that many Medical Officers/ Paramedics other Officials/ Staff Members from different field health institutions are frequently visiting the Directorate without seeking proper permission from concerned Drawing & Disbursing Officers which is against the standing instructions/rules. This practice is badly affecting the patient care and also results in indiscipline at various levels.

As such it is hereby ordered that no Medical Officer/ Paramedic or any other employee /staff member of any health institution/office shall leave his/her station unless and until proper permission is sought from the competent authority in writing.

All the Chief Medical Officers/Medical Superintendents/ Block Medical Officers and other Drawing & Disbursing Officers shall ensure that no Medical Officer/paramedic or any other employee /staff member of the department visits this Directorate without seeking proper permission.

Any deviation in this regard shall invoke serious disciplinary action against the

erring officer and official.
