Now, therefore, in view of the submissions/recommendations made by Chief Medical Officer Kupwara in terms of aforementioned letter dated:03.01.2018 Mst. Shameema Begum W/O Mohd Ashraf Sheikh R/O Sheikh Colony Handwara District Kupwara is hereby appointed as "Safaiwalla" on regular temporary basis on compassionate grounds under SRO 43 of 1994 in the Pay Level SL-1 (14800-47100) plus usual allowance as admissible under rules against the available post of safaiwalla at Block Handwara District Kupwara, subject to condition that she will look after and serve the dependent of her deceased mother and in case she violates terms and conditions of the affidavit submitted/ solicited by her in this Directorate, her services shall be terminated abintio without any notice.

"The salary of the candidate shall not be released unless & until the authentication of verification of her certificates alongwith her character/ antecedent certificate are received from the concerned verifying agency as well as Additional Director General of Police CID Jammu/ Srinagar. In case any certificate(s) produced by the applicant are proved fake/ forged, her appointment order shall be deemed to be cancelled ab-intio:

The Chief Medical Officer Kupwara will allow the appointee to join within 21 days from the date of issuance of this order only after the production of following documents in original, in case she fails to join within the stipulated time her appointment order shall be cancelled without any further notice. The appointment of the appointee shall be

governed under the provisions of SRO 4 00 of 2009 dated:31.12.2009 New Pension Scheme (NPS) and the appointee shall be on probation for a period of two years:-

- 01. Academic Qualification Certificate.
- 02. Date of Birth Certificate (10th)
- 03. Domicile Certificate.
- 04. Health Certificate from the Chief Medical Officer Kupwara.
- 05. Dependent / Legal Heir Certificate issued by the Revenue Department.
- 06. No Loan Certificate under Self Employment Scheme from DIC concerned and Employment Department.
- 07. Un-employment Certificate from District employment Exchange.
- 08. All other relevant documents as are required under SRO-43 of 1994 and other Acts/Rules presently in vogue on the subject.
