Subject:-Placement of Jr. Assistant as I/C Sr. Assistant and posting thereof.

Whereas, the Jr. Assistants of Kashmir Division whose services were regularized prospectively on the recommendations of Empowered Committee (ECM) under different orders issued by the Administrative Department had represented this Directorate for their promotion to the next post as Sr. Assistant in view of the fact that they have completed more than 03 years of service.

Whereas, after examination of their representation, it was found that officials figuring in the final seniority list of Jr. Assistants from S.No.01-19 issued by this Directorate vide Circular No.Est-5/NG-309/S.L/JA/3032-82 Dated:-30.08.2018 were eligible for their promotion to next post as Sr. Assistants in terms of provisions contained in the SRO-159 of 29<sup>th</sup> May of 2009 except S.No.06, 08 and 14 due to one or the other reason.

Whereas, thereafter the eligible 16 Jr. Assistants were placed as I/C Sr. Assistants vide this office Order No.203/NG of 2020 Dated:-29.07.2020 after their allied connected documents were found in order and the orders in respect of one Ravinder Kour Jr. Assistant of DTC Srinagar was kept withheld in view of the fact that FIR was registered against her in the office of Vigilance Organization Kashmir now called as Anti Corruption Bureau (ACB) under No.30/2017 US 5(1)(d) r/w 5(2) J&K PC Act Svt, 2006 & Section 467,468,471 and 120-B PRC into the allegations of fake appointment made in favour of one Bashir Ah. Reshi S/O:-Gh. Mohammad Reshi R/O:-Watnoo Tangmarg of CMO's Office Srinagar.

Whereas, the said official represented this Directorte through her controlling officer viz Director DTC Dalgate Srinagar who in terms of en-dorsement No. STDC/Sgr/73 Dated:-16.07.2020 recommended her case to be forwarded to the concerned agency for seeking vigilance clearance in her favour with the remaks that her work and conduct has remained quite satisfactory.

Whereas, this Directorate taken cognizance of the matter communicated with Additional Director General of Police VOK vide this office letter No.Est-5/NG/309-II/P.F/1134 Dated:-28.09.2020 with the request to intimate the status of the case registered in their office along with the comments with regard to issuance of necessary clearance certificate in favour of said official.

Whereas, in response to this office letter Dated:-28.09.2020, Assistant Inspector General (Hqrs) Anti Corruption J&K Srinagar vide letter No.ACB/36-11/NOC-2020-Misc/15830 Dated:-19.10.2020 intimated that the matter be routed through General Administration Department J&K along with complete posting details of the official in original or in authenticated shape.

Whereas, accordingly taking recourse of the instructions of the ACB, this office requested Director TB Demonstration Centre Dalgate Srinagare vide this office letter No.Est-5/NG/309-II/P.File/1350 Dated:-11.12.2020 to furnish the posting details of Ravinder Kour Jr. Assistant as per the format issued by GAD vide Circualr No.11-GAD(Vig) of 2018 Dated:-10.04.2018.

Whereas, in reaction Director T.B Demonstration vide letter No.STDC/Sgr/120 Dated: 17.12.2020 furnished the posting details of the official as per the devise format and accordingly this office forwarded the case to the Administrative Department along with the factual details of the case and posting details of the official as per the devised format for further course of action from them vide this office comminque No.Est-5/NG/309-II/P.File/1414 Dated: 23.12.2020.

in response to this office letter Dated:- 23.12.2020, Administrative Department vide letter No.HD/NG-K/26/2020 Dated:-08.03.2021 while forwarding the copy of O.M GAD(Vig)07-NOC/2021-HME Dated:-23.02.2021 received from General Adminstration Department therein reported that as per name, designation and posting details provided there is no preliminary enquiry/FIR pending against 78 officers/officials of H&ME Department including Ravinder Kour Jr. Assistant of STDC Dalagate Srinagar figuring at S.No.05 in the said OM Dated: -23.02.2021.

As such in view of the details narrated hereinabove coupled with the vigilance clearance received from General Administration Department through Administrative Department vide letter Dated:-08.03.2021 in respect of official under discussion which transpires that no preliminary enquiry/FIR is pending against her. As such Sanction is hereby accorded to the placement of Mtr. Ravinder Kour Jr. Assistant of State TB Demonstration Centre Dalagate Srinagar as I/C Sr. Assistant in her own pay and grade (OPG) with charge allowance as admissible under rules against the available vacancy in the department subject to the clearance/confirmation of the Departmental Promotion Committee as has been done in respect of her counterparts/contemporaries who also stand confirmed against the post of Sr. Assistants on the recommendations of Departmental Promotion Committee held in this

The above placement shall not create any right, interest or equity or any preferential Directorate on 17.08.2020. right upon aforementioned official as Senior Assistant as and when the promotions are considered on regular/subastantative basis, which shall be done strictly as per seniority and merits and shall be subject to the outcome of writ petition(s), if any, pending before any competent Court(s) of law.
