Subject:- Compassionate appointment case of zubair Ahmad Wani S/O Late.Mushtaq Ahmad Wani working as class-Iv at maternity and child care hospital Anantnag under SRO-43 of 1994.

ORDER NO. 920 Nag 2017 DATED; 14-10-2017

Whereas, this office has received the compassionate appointment case of Zubair Ahmad Wani S/.O Mushtaq Ahmad Wani deceased Class-Iv R/O Dailgam District Anantnag. Vide Chief Medical Officer, Anantnag letter No. Est/Iv/6969-70 dated 17-12-2015, for consideration of his appointment under SRO 43.

Where as, deceased namely Mushtaq Ahmad Wani was working as Class-Iv (Nursing orderly) at Maternity and Child Care Hospital District Anantnag on regular establishment who died in harness on 31-10-2015, as per the death certificate issued by the Station House Officer, Anantnag.

Whereas, as per dependence certificate issued by the Addl. Deputy Commissioner, Anantnag Vide No. 272/LH/Dep/SRO-43/Dep/2/SRO-43 dated 8-12-2015, the deceased has left behind the following dependents;

Whereas, the compassionate appointment case of Mr. Zubair Ahmad Wani S/O Mushtaq Ahmad Wani applicant was submitted to the Administrative Department vide this office letter No.Est-I/NG/132 dated 11-3-2016, for relaxation in lower age.

Whereas, in turn Administrative Department vide letter No. HD/NG/143/2016 dated 2-7-2016 desired to settle the case at level of this Directorate as and when the applicant attains the required age limit i.e, 18 years

Whereas, the applicant after attaining the required age of 18 years, applied in this office vide application dated 24-05-2017 for issuance of formal appointment order in his favour on compassionate grounds in terms of SRO-43 of 1994 and accordingly submitted all requisite certificates/documents in support of claim..

Whereas, in support of claim, the above named incumbent submitted the undertaking / affidavit on behalf of Dependent No.1,2,3,4 duly attested by Judicial Majistrate Ist class Doura to the effect that they will have no objection if dependent No.5 (Zubair Ahmad Wani S/O Late Mushtaq Ahmad Wani) is appointed in terms of SRO=43 on compassionate grounds.

Whereas, the Dependent No. 5 has also submitted an affidavit duly attested by the Judicial Majistrate Ist class Dooru to the effect that he will look after the other dependents of deceased on availing the benefit of appointment.

Whereas, the requisite certificates have been got verified and nothing has been reported adverse by the concerned agencies on verification.

Now, therefore, keeping in veiw the position given here in above, sanction is hereby accorded to the appointment of Zubair Ahmad Wani S/O Mushtaq Ahmad Wani deceased Class-Iv (Nursing orderly) R/O Dailgam District Anantnag on regular temporary basis on compassionate grounds in terms of SRO 43 of 1994, against the post caused vacant at Maternity and Child Care Hospital Anantnag due to the death of his father in the pay band of 4440-7440 with grade pay of Rs. 1300.

The applicant shall join in the office of Chief Medical Officer, Anantnag within a period of 21 days subject to the following conditions and production of required certificates

- a. State subject certificate.
- b. Qualification certificate.
- c Non-Loanee Certificate.
- d. Legal heir
- a. The chief Medical officer, Anantnag shall not draw his salaries until and unless the verification report with regard to character/ antecedents is received from concerned agencies.
- b. The appointee shall be on probation for a period of (02) years which he should have to complete satisfactory.
- c.That the appointee will look after the family left behind by the deceased as per affidavit submitted by him. In case any thing adverse is reported and proved the appointment shall be treated as cancelled.
